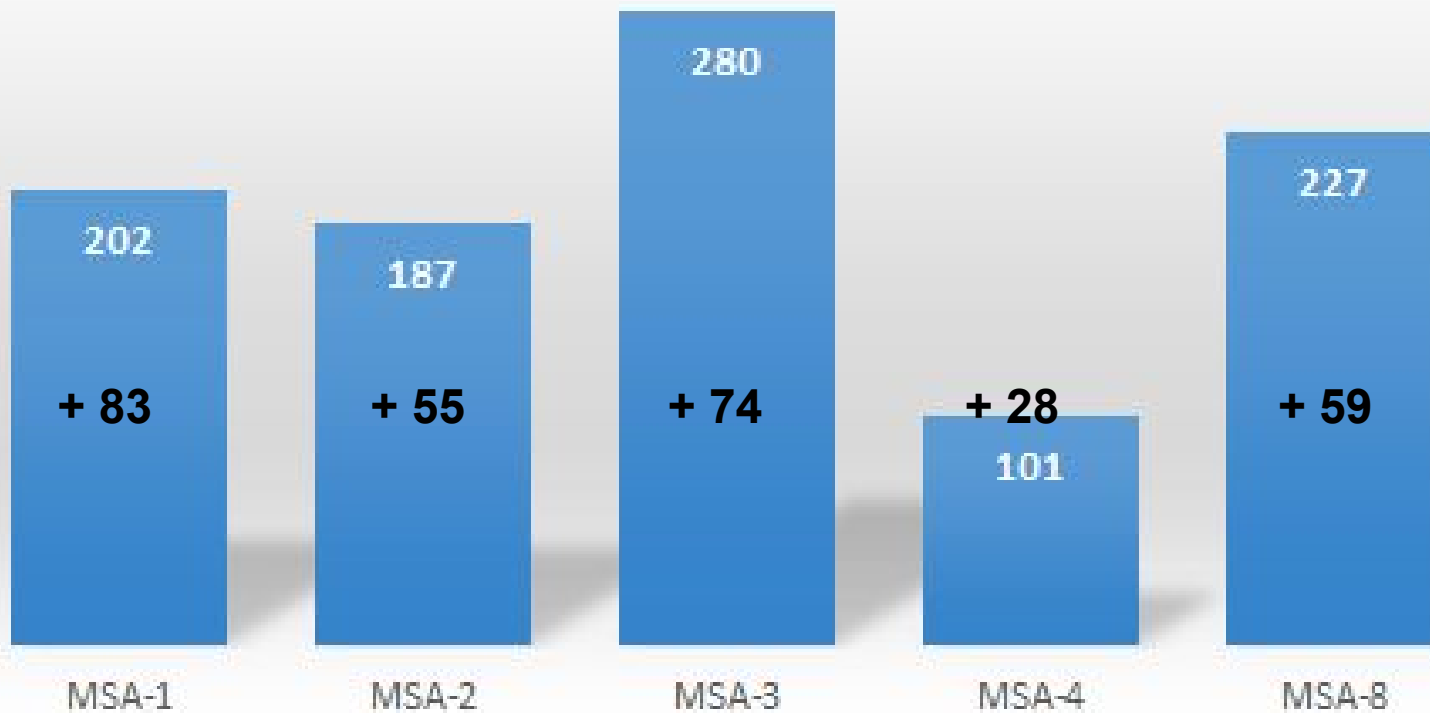

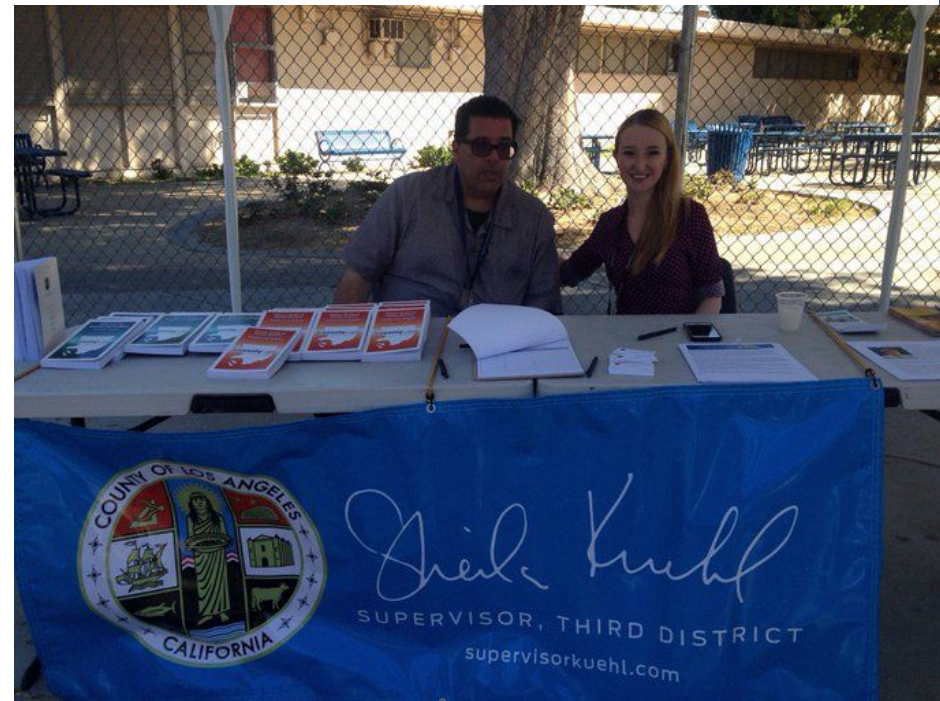

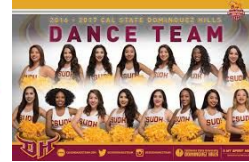
COMMUNITY FESTIVALS AT MPS
