### Proposed Board Motion

I move that the board approve the calendar for 2020-21 Regular MPS Board Meetings and Regular MPS Board Committee Meetings.

#### Introduction

Per the MPS Board Bylaws, meetings are held the second Thursday of the month unless otherwise stated. For 2020-21 Regular Board Meetings, most meeting dates follow this practice except the meetings in January and April due to Winter and Spring Break, respectively.

2020-21 will be the first full school year in compliance with new SB 126 regulations. One specific change due to SB 126 that directly affects these calendars is the meeting locations. Beginning 2020-21, all Regular Board Meetings will be held within the jurisdiction of Los Angeles County, where the majority of the MPS student population resides. All 12 meetings will be held amongst MSA 1-8 and the MPS Home Office. Additionally, per SB 126, all school sites (MSA 1-8, MSA-Santa Ana and MSA- San Diego), must remain open as remote locations during the duration of all special, emergency and regular committee and board meetings.

#### **Budget Implications**

Costs associated with these meetings will be approved in the 2020-21 MPS budget. Each school site will budget for staff compensation for the extra hours worked during board/committee meetings.
