# Proposed Board Motion

#### Background

In accordance with Education Codes 35143, 42632, and 42633, the Certification of Signatures form is required to formalize the personnel authorized to sign orders for salary or commercial payments, notices of employment, and contracts.

The form approved on June 11, 2020 had Serdar Orazov as a Board Member, this new form to be in effect August 7, 2020 removes Serdar Orazov as Board Member and places him as the MPS Chief Financial Officer. Additionally former Chief Financial Officer, Nanie "Ernany" Montijo is removed from effective August 5, 2020.
