RE:	Approval of Tao Rossini, APC, as a Legal Vendor to MPS

#### 1. Action Proposed:

Staff recommends and moves that the Board approve the law firm of Tao Rossini, APC, as a vendor to provide services to MPS and its schools as the need may arise.

#### 2. Purpose:

The purpose of this action is to provide MPS with access to the best and most relevant legal resources, including legal vendors with expertise in different areas of the law. The requirements of the award are complex and therefore MPS requires expertise in this specific area of the law.

#### 3. Background:
