Proposed Board Recommendation

I move that the board awards the winning bid according to vendor evaluation matrix and adopt the purchase of the Chromebooks for Magnolia Science Academy-8 operating within the approved budgeted amounts. Should there be a similar Chromebook model and charging carts need for any other Magnolia Public Schools, the approved vendor, machine model, and price will be used between dates July 1st, 2016 – June 30th, 2017.

Background

Magnolia Public Schools started implementing 1:1 mobile devices initiative in 2013-14 school year with purchasing of mobile device per student. Currently all schools implemented 1:1 except MSA-7 elementary. Magnolia Science Academy-8 purchased chromebooks last year with one cart per two classrooms. This year the school wants to provide chromebooks per student and staff members.

We released RFP on June 7th, 2016 and evaluated it according to following factors.
