<p>The SCSF staff recommend an emergency grant of \$32,600 to Ivy Preparatory Academy in order to meet unexpected needs. Funds will be utilized to pay for counseling services for five weeks for students and teachers affected by a recent event on campus and to install physical barriers in front of the school to prevent vehicles from breaching the building.</p>			

Ivy Preparatory Academy will be required to submit reports documenting appropriate expenditure of funds. This grant award is contingent upon the SCSF's receipt of funds for this purpose.

Phase I of the Replication and Expansion Cohort program is ending, and the six schools/networks are beginning technical assistance with the Georgia Charter Schools Association's Incubator and continuing work with GCSA's Facility Resource Center. The New School Leader Fellowship program continues, and plans are being made for the roadshow stops and roll out of FindaGaCharter.org.

The application window for eligible schools that are replicating, opening, or expanding Fall 2023 will open this week. Grant recommendations will be presented to the board in January, and the grant application will remain open until all grant funds are committed. We anticipate strong demand, exceeding fund availability.
