Item #3 LCAP Update

Ms. Fuentes, reminded the committee that several of the areas on the LCAP are also being reviewed and captured by the stakeholder conversations regarding the WASC process. Data gathered for the WASC will also be included and used for the LCAP process this year. In April we will review the budget as it aligns to the current LCAP to see if we want to keep the same areas of focus as we continue to review

Claudia Melendez, daily random backpack checks, monitoring student email, blocking inappropriate websites. Give all parents the opportunity to attend drug awareness and prevention workshops. Making parents knowledgeable of what is recent on the street regarding drug abuse. In efforts to bring more control of marijuana infused products, not allowing outside food on campus.

Adriana Sanchez, security at the beginning and entrance of the school campus. Students are being more strategic now a days in bringing in drugs or alcohol on school campus.

Christina Soria, the creation of the school climate & culture committee addressing student behavior. Continue to use assembly time to discuss drug prevention awareness. More teacher training on emergency protocols and procedures; monthly training. Improving school communicating between two schools for guicker notification.

Cesar Guzman, more trash bins and recycling bins around campus; keeping school clean. School small enough, notification of any bullying are made aware to administrations fairly quickly. Administration acts on and bullying since school has a zero tolerance on bullying. Solve conflict between students, allow students to come together and speak on pressing issues and bring a resolution of respect. Safety bins in each classroom with emergency supplies.

Karla Sanchez, students don't take it seriously when having fire, lockdown drills. Address the students of the importance of the drills.

Yolanda Fuentes, internet safety policy signed by each parent and student; informing them with school expectations. Currently working with our K-9 company in providing parent meetings/workshops to bring awareness, and knowledge and preventions. Also, collaborating with Phoenix House organization to provide a 6 week parent workshop; drug prevention. Recent rise of issues at schools of marijuana edibles throughout the city of, marijuana infused chips, drinks. New this school year, Mr. Cruz' position of School Climate & Culture who now focuses on student behavior and discipline. We haven't had an issue on discrimination this school year, therefore as a preventitive measure, we use Ripple Effects a student online program to provide social emotional support through educational modules and student reflections. Having our own school campus can create a more safe environment verses being co-located with a middle school.
