- Finance Committee Recommends We Open A Second Savings Account At GOCU, a High Yield Savings Account.
- 3. GOCU Is Our Bank for saving "Overflow" Funds from Our Truist Account so we keep a reasonable balance in the Truist Account ... Around \$250,000.
- 4. Our Treasurer Transferred An Initial \$25,000 to the GOCU Savings Account from the Truist Account. He will manage the balancing of funds held in the various accounts, therefore needs approval to potentially transfer large sums of money in excess of \$50,000 at a time. He will report the transfer activity and the bank balances to the Board Monthly.
