ISSUES INVOLVED/FISCAL IMPLICATIONS (IF ANY):

The purpose of this action is to approve the APEX proposal/contract for 2023-24 and 2024-25.

This virtual curriculum will be used by many departments, including Credit Recovery, Special Education, Pali Academy, Summer School, etc. The school currently uses Acellus. However, PCHS began exploring alternative providers in Spring of 2023.

The recommendation is to use APEX for the remainder of 2023-24 at a cost of \$4,500 (unbudgeted). The annual cost for 2024-25 would be \$62,500, approximately \$10,000 less than the current provider (Acellus).

This was also the recommendation from the Curriculum Council and the Admin team.

The action requested of the Board today will support the goal of improving academic achievement and proficiency.
