Section 3: Students			

A. The School is authorized to serve students in grades 6 through 12. See section F.2. below

for the grade levels and enrollment for each year of this Charter Contract.

The School may provide enrollment preferences as allowed for in section 1002.33(10), Florida

Statutes. Further, the School may limit the enrollment process to target specific student populations

asset forth in section 1002.33(10)(e), Florida Statutes, or as described in the approved Application.

The School shall comply with the requirements of controlled open enrollment, as set forth in ss.

1002.20 and 1002.31, Florida Statutes.

The School will accept all eligible students in accordance with federal and state anti-discrimination

laws and in accordance with the Florida Educational Equity Act, section 1000.05(2)(a), Florida

Statutes. The School will not discriminate on the basis of race, gender, ethnicity, religion, national

or ethnic origin or disability in the admission of students. The School may not request prior to

enrollment, through the application or otherwise, information regarding the student's prior

academic performance. Pursuant to section 1002.33(7), Florida Statutes, admission or dismissal

must not be based on a student's academic performance.

The School shall be non-sectarian in its programs, admissions policies, employment practices and

operations. The School will meet all applicable state and local health, safety, and civil rights

requirements. The School will comply with all applicable provisions of the Marjory Stoneman

All emails received will be retained as public records pursuant to chapter 119, F.S.
- Each individual must include his/her name, address, and what organization, if any, s/he represents in the email. Anonymous comments will not be accepted.
- Written public comments will be included as part of the meeting record but will not be read out loud.
- Public comments must be limited to 3 minutes (approximately 400 words).
- Individuals giving public comment must refrain from direct questions to Board Members, school staff, or members of the audience.
- Public comments that include profane or vulgar language or personal attacks are prohibited.
- Public comments that are not timely or that do not comply with these requirements will not be included as part of the meeting record.
- The Board Chair reserves the right to maintain decorum at any meeting and to end any individual's presentation of public comment that does not comply with these requirements.
