Note: LCPS, along with many other district and charter schools, use DTS (a document tracking service for school compliance). DTS has shared that CDE has not updated key data tables and will not do so by the 1/31 deadline. Hence, DTS has advised that we approve and post the SARC even though the data may be blank or outdated. Once the

CDE's data issues are resolved, the data will be uploaded and revised SARCs will be posted on-line.

Below is a list of key data point clarifications in the SARC:

- Section A: Conditions of Learning:
 - \circ The data in this section is blank because CDE/CBEDS has not updated their data file
- Section B: Pupil Outcomes:
 - LCPS took CAASPP in the spring of 2021. However, the comparative state data is listed as "N/A" because only a percentage of schools statewide took these assessments.
 - Local Assessment Test Results. Because LCPS took CAASPP in 2021, we are not required to populate these sections.
- Section D: Other SARC Information
 - Class Sizes: The data is pulled from a CALPADs submission, and will need to be corrected / updated once the data table issue is resolved.
 - Student Support Services Staff: CDE/CBEDS has not updated their data file
