J. Diossa called a meeting of the board of directors of Blackstone Valley Prep Mayoral Academy to order on Monday Oct 26, 2020 at 5:34 PM.

#### C. Vote to Approve Minutes 10/5

- D. McKee made a motion to approve the minutes from Board Meeting on 10-05-20.
- W. Murray seconded the motion.

The board **VOTED** unanimously to approve the motion.

#### D. Public Comment

Monia Cabral spoke to pose a question about BVP's plans for in-person learning in Trimester 2. The Board will address this topic later in the agenda.

## II. Recurring Items

#### A. CEO Report

J. Chiappetta called attention to highlights of the CEO report, as included in Board Packet. In particular, he noted that BVP has experienced a number of staff and scholar quarantines, and has had to close campuses and/or in-person classrooms.

Also of note, BVP has two finalists for the prestigious Questbridge National College Match, which helps to match 1st generation college applicants in the nation with top-ranked colleges and universities.

- D. McKee made a motion to accept the CEO report as presented in Board packet.
- J. Almond seconded the motion.

The board **VOTED** unanimously to approve the motion.

#### **B.** CFO Report

- C. Losea presented highlights of the CFO report as included in the Board Packet, including:
  - The finance team has been working with KLR to finalize the annual audit, which will be presented later in the agenda.
  - An RFP has been issued for facilities funding
  - BVP has been granted access to BankRI's PPP Forgiveness portal as of today. The finance team will be working to complete that process.
- J. Waters mentioned some grants she has learned of from the Rhode Island Foundation, that BVP may be eligible for in its effort to support families through this difficult time.
- J. Silva made a motion to accept the CFO report as included in Board Packet.
- J. Morton seconded the motion.

The board **VOTED** unanimously to approve the motion.

#### III. New Business Items

#### A. Reopening Update

J. Chiappetta shared a presentation outlining the context in which BVP is currently operating. At this time, BVP is still operating under its partial return plan with in-person instruction available to K-4 families and a limited number of scholars in 5-12 who are considered to be most in need of in-person instruction. The Board engaged in conversation about plans for the near future, including discussion about delays in contact tracing and notification, staffing challenges due to quarantines, and whether BVP should seek to bring more scholars back into buildings for in-person learning. No vote was taken, but the consensus at the end of the conversation was to continue to operate the partial return plan, and not to pursue bringing more scholars in-person at this time.

#### B. FY20 Audit Report

- P. Martin and J. Parmer of KLR presented the FY20 audit report. They issued a clean opinion and found no material deficiencies.
- J. Morton made a motion to accept the audit report.
- J. Silva seconded the motion.

The board **VOTED** unanimously to approve the motion.

#### IV. Closing Items

Hi Beth! Hope you're well! Here's what I'd like to share with the board:

Dear Board Members,

My name is Johnna Gonzalez and I'm a parent of two ES2 scholars - a kindergartner and a 3rd grader. Firstly, I'm incredibly grateful to the board, BVP leadership, and our wonderful teachers for your transparency and effort during COVID. I know you've had to make impossible decisions with inadequate choices, all knowing you won't make everyone happy. As you vote to determine if BVP should continue to offer partial in-person learning or move to distance, I imagine you'll weigh several factors. I'll leave the potential health risks to medical experts, and the staffing/logistical challenges to Jeremy and team, but would like to share my experience with in-person learning during COVID.

I've seen some speculation about the quality of in-person learning during COVID and questions about if it's *really* much more effective than distance learning. I worried about this myself when considering our options at the start of the year. I want to be clear - even with the COVID restrictions, my children are having a wonderful experience in person. Both kids adore their teachers, are thriving socially, and are bursting with enthusiasm to go to school each day. My 3rd grader's writing ability has improved significantly, and my kindergartner is learning to read.

By comparison, distance learning is incredibly stressful, particularly for my kindergartner. There's little joy in kindergarten over zoom. My five year old does not have the attention span to sit in front of a computer for more than a few minutes and requires 1:1 support from a parent to stay even partially engaged. Even in our incredibly privileged situation of having two parents working full time from home, juggling his learning and our work responsibilities is unsustainable. This setup will never be as effective as an in-person teacher. I can't imagine how difficult this must be for parents and children in more challenging situations. I also recognize that for some families, distance learning is working beautifully.

I understand that even as you recognize the benefits of in-person instruction, you may still move BVP to a more restrictive plan due to health risks or staffing issues. I'd ask that you consider keeping the school's youngest and most vulnerable scholars in school as long as possible.

#### Hello Mr. Chiapetta,

Good evening. I will start with saying that we appreciate all that you and the BVP team has done for scholars this year. I myself am a teacher and I see, live, and work all of the new challenges we have been given. So very sincerely, we thank you and we pray for your peace and continued patience.

I am reaching out today because, although I am not on social media, someone made me aware that on FB there was an announcement of a board meeting. It's my impression, from the message that I received, that there is a vote for the limited plan or full distance learning and in-person is off the table. I believe this would be distance learning for the grand majority of the district except for kinder and VIPs. I did not realize that the board would be making decisions on closing without the push from the governor. I will be honest and say that I am very disappointed and disheartened to hear this. In addition to the complications it poses to our family personally (we literally have NO ONE to care for our young children on a long term basis as I teach in-person with no other option and my husband runs his own business) we have heard over and over again the importance of young children being in school. Isolation, lack of activity, prolonged abuse, depression, anxiety, less effective instruction... I know you know the list goes on. For our family the decision for in-person instruction was extremely easy. We are more willing to take the risk with COVID-19 than to risk the long list of guaranteed complications with isolation and distance learning. That may sound harsh to some but it is our truth.

This is a plea to you and the BVP team to do whatever it takes to allow in-person schooling to continue. We understand the challenge is EXTREME, but so should be the priority of each scholar's social, emotional, and academic needs.





# As of 11/19: R-naught is the "spread" of the disease The aim is to be <1.0; RI is at 1.23 (10th highest in the US)




# RI Record setting hospitalizations on 11/17

# **COVID Concerns:**

- At least 54 in-person scholars out due to quarantine
- 9 staff members out due to quarantine
- 4 in-person scholars are known positive
- 4+ awaiting results as probable cases

# **Substitute Partnership with Highlander:**

- Requested and assigned ten substitute candidates
  - Two completed the Highlander training
    - One only willing to be remote
    - One willing to teach in-person; available 3 days per week

# **Broader Rhode Island context**

- Governor announced state-wide implementation of a Limited Plan for High School
- Some school systems have opted not to open to in-person instruction yet this year
- Several schools are switching to distance learning through New Years

# RESOLUTION OF THE BOARD OF DIRECTORS OF RHODE ISLAND MAYORAL ACADEMY (SM) BLACKSTONE VALLEY

(52 Broad Street Acquisition and Financing and Refinancing of Other Outstanding Indebtedness)

Whereas, Civic Broad Street Corporation ("Landlord") and Rhode Island Mayoral Academy (sm) Blackstone Valley ("RIMABV") entered into a Lease Agreement dated as of November 6, 2013 (the "Lease") for certain Demised Premises thereunder located at 52 Broad Street, Cumberland, Rhode Island, (the "Premises");

Whereas, pursuant to the Lease, RIMABV holds an option to purchase the Premises pursuant to the Purchase Option Agreement set forth in the Lease for a price to be computed as specified in the Lease;

Whereas, Equitable Facilities Fund ("EFF") and the Rhode
Island Health and Educational Building Corporation ("RIHEBC")
have indicated a willingness, under certain terms and conditions, to

provide financing to RIMABV for the purchase and acquisition of the Premises in accord with the EFF term sheet attached hereto as Exhibit A and hereby incorporated by reference herein;

Whereas, it is anticipated that RIHEBC will agree to issue a conduit revenue bond, note or other contract of finance to be purchased by EFF or its affiliate and will pledge same as collateral security for a certain bond or bonds to be issued for the benefit of EFF or its affiliate(s) and/or RIMABV by the Arizona Industrial Development Authority;

Whereas RIMABV has incurred indebtedness, currently outstanding, in the approximate amount of Three Million One Hundred Thousand and 00/100 Dollars (\$3,100,000.00) to BlueHub Loan Fund, Inc. and CSGF Facility Fund III LLC in connection with the construction and renovation of RIMABV's Fairlawn School facility in Lincoln, Rhode Island leased from the Town of Lincoln (the "Fairlawn Debt");

Whereas, RIMABV and School Holdings I, LLC, whose sole member is RIMABV, have incurred indebtedness, currently outstanding in the approximate amount of Four Million and 00/100 Dollars (\$4,000,000.00) to Self-Help New Markets IX, LLC and Self-Help New Markets X, LLC in connection with the acquisition, construction and renovation of RIMABV's 291 Broad Street real estate and facilities thereon in Cumberland, Rhode Island (the "291 Broad Street Debt");

Whereas, the actions and resolutions set forth below by the Board of Directors of RIMABV are required in order for RIMABV to purchase and acquire the Premises and to finance the purchase and acquisition of the Premises and to refinance and refund the Fairlawn Debt and the 291 Broad Street Debt and to pay the transaction costs and expenses and the cost of bond/note issuance associated therewith.

NOW THEREFORE, does RIMABV resolve as follows:

Resolved: That RIMABV be and hereby is, authorized and empowered to execute the option to purchase under the Lease and to acquire and purchase the real property and all improvements thereon designated in these resolutions as the Premises also known as 52 Broad Street, Cumberland, Rhode Island, to enter into such agreements, contracts, documents, papers and/or instruments, as the Authorized Person (hereinafter defined), deems necessary or desirable to consummate the foregoing purchase and acquisition transaction set forth herein and to pay a purchase price for the Premises in an amount not to exceed EIGHT MILLION FOUR HUNDRED AND 00/100 Dollars (\$8,400,000.00);

Further Resolved: That RIMABV and/or School Holdings I, LLC be and hereby is authorized and empowered to borrow an amount not to exceed SIXTEEN MILLION AND 00/100 Dollars (\$16,000,000.00) at a rate not to exceed Five Percent (5.00%) to (i) finance the purchase and acquisition of the Premises; (ii) payoff, refinance and refund the Fairlawn Debt; (iii) payoff, refinance and

refund the 291 Broad Street Debt and (iv) pay the costs and expenses of the transactions set forth in this Resolution and the costs and expenses of the note/bond issuance contemplated thereby and the establishment of any reserves or escrows required in order to effectuate the transactions set forth in this resolution and to borrow said amount from EFF and/ or its affiliates and/or RIHEBC and/or the Arizona Industrial Development Authority and in connection therewith to grant, execute and deliver a mortgage or mortgages to EFF and/or its affiliate(s) and/or RIHEBC and/or U.S. Bank National Association, as Master Trustee under the Master Trust Indenture dated as of April 1, 2019 as to which RIMABV is a party, encumbering the Premises, a security agreement or security agreements encumbering the real or personal property of RIMABV, such notes, bonds, indentures, pledge agreements, control agreements, guaranties, certificates, applications, including, but not limited to, an application for the financings contemplated by this Resolution to RIHEBC, ratifying any such application or applications heretofore executed or

submitted, or other papers, instruments and documents as the Authorized Person deems necessary or desirable including but not limited to documents, instruments or papers of RIMABV acting hereunder as the sole member of School Holdings I, LLC to effectuate the acquisition and/or financing of the Premises and the intents and purposes of these resolutions including, but not limited to, such papers or documents as may be necessary or desirable to obtain a credit rating from Standard & Poors Rating Agency or other credit rating agency, and to pledge and encumber the revenues of RIMABV hereby ratifying and approving all actions heretofore taken by RIMABV, its officers, employees, agents and Authorized Persons consistent with the intents and purposes of these resolutions and that all such financing referenced in these resolutions shall be in substantial compliance with the term sheet furnished by EFF attached as Exhibit A hereof and hereby incorporated by reference herein;

Further Resolved, that Jeremy Chiappetta, Executive Director and Chief Executive Officer of RIMABV, and Christine Losea, Director of Finance of RIMABV, each acting singly (individually, the "Authorized Person" and collectively, the "Authorized Persons") be and each hereby is authorized and empowered to execute and deliver any and all documents, instruments, papers, notes, bonds, contracts, mortgages, guaranties, pledge agreements and the like on behalf of RIMABV and on behalf of RIMABV as the sole member of School Holdings I, LLC and in furtherance of or in connection with the transactions set forth in these resolutions with such amendments and modifications as the Authorized Person determines necessary or desirable, the signature on any of the foregoing by the Authorized Person being evidence of such determination;

Further Resolved, that Hilltop Securities, Inc. be and hereby is approved and ratified as financial advisor to RIMABV in connection with the transactions contemplated by this Resolution

for a fee for services not to exceed Twenty Thousand and 00/100

Dollars (\$20,000.00) and that the signing of a contract for the

foregoing consistent with the provisions hereof be and hereby is

approved and ratified.
