# EXECUTIVE COMMITTEE OF THE BOARD OF DIRECTORS OF THE ELGIN MATH AND SCIENCE ACADEMY CHARTER SCHOOL

## RESOLUTION AUTHORIZING EMSA'S WITHDRAWAL FROM ILLINOIS SPECIAL EDUCATION CHARTER COOPERATIVE (ISECC)

**WHEREAS**, on March 2, 2022, the Board of Directors approved a "Board Resolution For ISECC To Abide By Joint Agreement and ISECC's Policies and Procedures"; and

**WHEREAS**, after the approval of said Resolution, EMSA became a member of ISECC, which supported EMSA's diverse learners' program for the 2022-2023, 2023-2024, and 2024-2025 school years; and

WHEREAS, Article VIII, Section 1 of ISECC's Second Restated Articles of Joint Agreement requires a withdrawing ISECC member to provide a petition to withdraw and a written resolution authorizing withdrawal, approved by the Member Charter School's Board, to the ISECC Governing Board, Executive Board, and Executive Director no later than eighteen (18) months prior to the proposed effective date of withdrawal; and

WHEREAS, EMSA's administration has recommended that EMSA withdraw from ISECC because it has concluded that the support and services provided by ISECC can be provided by EMSA staff who will maintain State of Illinois Special Education Director certification; and

WHEREAS, EMSA's administration has concluded that EMSA's withdrawal will benefit EMSA's finances as the costs of EMSA'S membership in ISECC will be eliminated; and

WHEREAS, EMSA projects that the financial impact on ISECC will be the loss of EMSA's membership fees; and

WHEREAS, EMSA does not project any educational impact on ISECC; and

WHEREAS, on March 26, 2025, the EMSA Board of Directors passed a "Resolution Authorizing EMSA's Withdrawal From Illinois Special Education Charter Cooperative" effective September 30, 2026, or July 1, 2026, if approved by ISECC; and

WHEREAS, Article VIII, Section 1. (A) of ISECC's Second Restated Articles of Joint Agreement requires a withdrawing Member to petition for withdrawal by notifying the ISECC Governing Board, the ISECC Executive Board, and the ISECC Executive Director; and

WHEREAS, EMSA made such notification on April 8, 2025; and

WHEREAS, Article VIII, Section 1. (A). 1.a of ISECC's Second Restated Articles of Joint Agreement requires the Governing Boards of the remaining Members of ISECC to adopt written concurring resolutions agreeing to the proposed withdrawal petition within six (6) months from when the petition for withdrawal was presented; and

WHEREAS, the Governing Boards of the remaining Members did not adopt written concurring resolutions within this six (6) month period; and

WHEREAS, Article VII, Section 2(a) authorizes the Executive Committee of the EMSA Board of Directors to act on behalf of the Board of Directors during the intervals between meetings of the Board of Directors provided that actions taken by the Executive Committee shall be reported to the Board of Directors for ratification at the next regular meeting thereof; and

WHEREAS, the Executive Board proposes that EMSA withdraw from ISECC effective July 1, 2026;

**NOW, THEREFORE, Be It Resolved** by the Executive Committee of the Board of Directors of the Elgin Math and Science Academy Charter School as follows:

**Section 1.** The foregoing recitals are incorporated herein by reference.

Section 2. The Executive Committee hereby authorizes the Executive Director to send this Resolution to the Board of Directors for ratification and to the ISECC Governing Board, ISECC Executive Board, and ISECC Executive Director by email and certified mail, return receipt requested, with a petition to withdraw, so that the remaining members can pass concurring resolutions.

**Section 3.** The Executive Director is further authorized to take any and all steps necessary to effectuate this withdrawal.

**Section 4.** This resolution shall take effect upon its adoption.
