Changes since last budget review:

- Dependent care coverage is included at an expected cost of \$60,000
- Compliance coordinator role was removed (\$65,000 in salary, plus benefits, removed)
- Social-emotional (SEL) position was removed (\$66,000 in salary, plus benefits, removed)
- Increased nurse salary from \$45,000 to \$75,000
- Rental equipment increased by \$12,000 for new copiers
- New laptops for team leads increased expenses by \$15,000
- Board on track subscription (\$6,000) included in expenses

Overall budgeting a \$161,068 net surplus for the year, which is an ~2.5% operating margin
