A. Spring MAP Scores FYI

- Both schools are demonstrating above average growth in Math overall and in Reading in primary grades.

**B.** PCA Advanced Placement and SCCA Dual FYI Enrollment Courses Coming Soon

PCA will be adding two AP courses over the next two years. We will begin with AP Seminar next year and then add AP Research the following year. These course will benefit students in several ways:

- The course will add additional weight for GPA (similar to Dual Enrollement courses)

- The course can potentially earn college credit (based on score on AP Exam and colleges' criteria)

- The course will better prepare students for the rigor of college classes, specifically in writing papers for these particuluar courses begin offered.

SCCA will offer these courses eventually, but will be starting up their Dual Enrollment program next year!! The benefits of Dual Enrollment courses are:

- DE courses add additional weight for GPA
- DE courses count as both high school and college credits
- DE courses better prepare students for the rigor and expectatins of college
