<p><b>A.</b> Approval of ELA Instructional Materials for GaDOE - PCA/SCCA</p> <p>As part of the new GA Early Literacy Act schools are required to adopt K-3 ELA instructional materials from the "approved" list OR use a rubric to determine if the materials they are using meet research-based practices. Curriculum Director, Kathy Bantz, has used the rubric to assess our current materials and determined that they do meet requirements. We have invested a lot of money and time into the current curricular programs, and also believe continuity of instruction is key to continued growth and achievement.
