| <p>- An amendment request has been submitted for PCA to add "students matriculating from Pataula Pre-K" as a 3rd enrollment priority. SCSC staff are recommending approval to their Board, and approval is anticipated prior to the lottery.</p> <p>- We were informed that SCCA cannot implement this enrollment priority until AFTER the CSP grant expires in March. Therefore, we cannot use this priority in January 2025 lottery (tomorrow) for SCCA. However, we have requested this change in our renewal application which would go into effect in July 2025, and be used as a priority for all lotteries AFTER that date.</p> | | | |
