Good Morning,

Please find attached the enrollment appeal form.

I am at the mercy of this committee as this was very difficult for me to write due to the fact that it determines the fate of my child's academic future in which I believe is hanging on a thin thread if he doesn't attend this school. This week has been overwhelming stressful and depressing for me as a mother. Today I received the uniform I ordered for Liam to begin his 8th grade year and all I could do is sigh in sadness. Liam has attended this school since second grade and although it wasn't always roses and chocolates Liam has over come some of his difficult social emotional issues at this school. We had one of the best teachers at the school who helped Liam and I when he had difficulty with expressing his emotions and ultimately received wraparound services (IEP) to address his mental health. Since then Liam has progressed and soared at this school which resulted in him no longer needing it. My biggest fear is having him abruptly leave this environment to ultimately have to adapt to new faces, new teachers, new friends. I am so scared that he will not excel as well as he has at Foxborough. I'm scared of the whole nuances of middle school peer pressure at a mainstream public school will trigger another episode of mental health that Liam can not handle.

I honestly was not aware that any of this has transpired. I never consented to Liam leaving as I knew the change could be difficult for him in the end. Liam is devastated and scared of the unknown. He did not realize the consequences of him and his fathers actions in completing those documents. As you were witness to me in your office I was in complete and utter shock upon receiving this document literally in tears. I would have never created such back and forth had I known that this had happened. I am pleading with the committee to overturn the decision as going to this school is the best option for Liam based on his need of support. This is also his older brothers last year of school and I need him to see the work and efforts that his older brother will do. I need his older brother to look out for him one last time. I need them to be together. This so crucial when raising a son. Thank you for taking the time to even meet with me in regards to this grave mistake.
