## 2027 Budget Revisions

### Revenue Summary:

Tuition – increase per pupil tuition to \$20,690/pupil.

- Budgeted Student FTE is 1395
- Total Tuition revenue at this rate is \$28,862, 550.
- Significant increase from first draft budget.

Federal Grants – Added projection of \$82,477 of potential savings carry over.

Private Grants – Awaiting determination from two grant applications

### Expense Summary:

Salaries - Proposed reductions to a range of district and school-level positions

- Some changes based on enrollment projections
- Additional reductions to staffing and support levels to create efficiency

Medical Insurance - Successfully decreased rate increase from 22.5% to 8.4%

- Revised plan to a higher deductible plan
  - Saving \$374,552
- Meeting with FRCSTA to review changes today

Operations - Categorized Kubota Snowplow to Capital Expense

- Capital increased \$50K to reflect change
- Continuing to review costs and renegotiate rates where possible
