## **II. Leadership Report**

### **A. Re-Opening Planning**

Data for this week has not been released by the Commonwealth for our review prior to the meeting. We reviewed the following data. The week of:

- 14OCT2020 22% of our communities were in Red Zones
- 22OCT2020 40% of our communities were in Red Zones
- 29OCT2020 86% of our communities were in Red Zones

This trend is in the wrong direction to support a reopening based on the current state guidance.

The recommendation is to open the school the week of Thanksgiving if the data supports it with Cohort A attending in person on Monday and Cohort B in person attending on Tuesday.

Given the Commonwealth has not been releasing data consistently on Wednesdays the board discussed moving our meetings back to Tuesday evenings.

Matthew Yezukevich made a motion to delay the transition to hybrid learning to no sooner than 23NOV2020 with a phased in approach.
