She most recently served as Site Director for College Track New Orleans and is grateful for her time spent preparing scholars to become first generation college graduates.

#### I. PURPOSE

For the health and safety of all Athlos Academy of Jefferson Parish's students, Athlos Academy of Jefferson Parish requires criminal background checks for all school employees, substitutes, and volunteers who interact with students and/or who could potentially be left unsupervised with a student. This policy specifically addresses the requirement for background checks for all board members with Athlos Academy of Jefferson Parish.

#### III. POLICY

- A. Anyone on Athlos Academy of Jefferson Parish's grounds or at one of its events with significant access to students, or unsupervised time spent with students, is required to submit to a criminal background check prior to engaging with students.
  - 1. For the purpose of this policy, this includes school board members.
  - Within 30 days of election and prior to taking seat, all school board members shall complete a criminal background check.
    - a. No person who has been convicted of or has pled nolo contendere to a crime listed in LA.
       R.S. 15:587.1(C) shall be elected to the school board.
  - 3. The governance coordinator at homecourt will work with the newly elected board member and staff at the school to secure the proper paperwork for the background check.

#### B. Background Checks Procedures:

- 1. At the beginning of the school year, all parents will be notified that Athlos Academy of Jefferson Parish requires background checks on all school personnel including board members, volunteers, emergency replacements, and substitutes.
- 2. Athlos Academy of Jefferson Parish will request criminal background checks on all board members, including fingerprints.
- 3. Unless a new board member has completed a background check through the Board of Elementary and Secondary Education within 12 months of the date of election, he/she must complete a background check through Athlos Academy of Jefferson Parish.

#### **Background Checks for Employees**

#### I. PURPOSE

For the health and safety of all Athlos Academy of Jefferson Parish's students, this policy requires that Athlos Academy of Jefferson Parish requires criminal background checks for all school employees, substitutes, and volunteers, and substitutes who interact with students and/or who could potentially be left unsupervised with a student. This policy specifically addresses the requirement for background checks for all permanent, part-time, temporary, or contracted Athlos Academy of Jefferson Parish employees,

#### II. POLICY

- A. Anyone on Athlos Academy of Jefferson Parish's grounds or at one of its events with significant access to students, or unsupervised time spent with students All employees of Athlos Academy of Jefferson Parish, is are required to submit to a criminal background check prior to engaging with students.
  - This includes all school employees, <u>both part-time and full time</u>, as <u>well as Governing Board members</u>, <u>volunteers</u>, substitutes, <u>and/or emergency replacements</u>.

<del>1. </del>

- 2. At the time of hire all employees shall complete a criminal background check.
  - a. No person who has been convicted of or has pled nolo contendere to a crime listed in LA.
    R.S. 15:587.1(C) shall be hired by Athlos Academy of Jefferson Parish as a teacher,
    substitute teacher, bus driver, substitute bus driver, or janitor, or as a temporary, part-time, or permanent school employee of any kind.
- a. 3. All contracted parties who will have access to students shall be required to have a criminal background check as part of the contractual agreement.
- 3. Volunteers shall acquire the necessary paperwork at the front office.

#### B. Substitute Teachers:

- 1. All substitute teachers are required to pass a background check for conditional employment.
- 2. No substitute shall be in contact with students other than to provide direct instruction or other services for which the substitute was hired, except as deemed appropriate by the Lead School Administrator.
- C. Volunteers (guest speaker, chaperone, teacher's assistant etc.):

#### **Background Checks**

- 1. Athlos Academy of Jefferson Parish requires criminal background checks on any volunteer who accompanies students off campus (i.e., chaperones for field trips), and any volunteer who may have unsupervised time with students.
- 2. Guest speakers and teacher's assistants shall be subject to heightened supervision by the Lead School Administrator.

#### D.C. Emergency Replacement:

- 1. In the case that an emergency replacement is necessary (i.e. a teacher suffers a medical emergency or is involved in a severe accident), an emergency replacement will be provided immediately.
- Emergency replacements shall be subject to heightened supervision by the Lead School Administrator.

#### E.D. Background Checks Procedures:

- 1. At the beginning of the school year, all parents will be notified that Athlos Academy of Jefferson Parish requires background checks on all school personnel including board members, volunteers, emergency replacements, and substitutes.
- Athlos Academy of Jefferson Parish will request criminal background checks on all school personnel, including finger prints.
- 3. Unless a new employee has completed a background check through the Board of Elementary and Secondary Education within 12 months of the date of hire, he/she must complete a background check through Athlos Academy of Jefferson Parish.
- 4. The cost of the background check may be the responsibility of the corresponding applicant/employee.
- 5. If a person is denied employment or dismissed based on information in a background check, he/she will receive notice of the reason, and will have the opportunity to respond.

#### F.E. Supervision Policy:

- The Lead School Administrator is responsible for supervising students to ensure their safety, and shall
  provide heightened supervision of substitutes, emergency replacements, volunteers and/or guest
  speakers.
- 2. Until a background check clears, the responsibility of supervision of lies with the Lead School Administrator or designee.

- 3. The cost of the background check may be the responsibility of the corresponding volunteer.
- 4. If a person is denied a volunteer opportunity based on information in a background check, he/she will receive notice of the reason, and will have the opportunity to respond.

#### C. Supervision Policy:

1. The Lead School Administrator is responsible for supervising students to ensure their safety, and shall provide heightened supervision of volunteers and/or guest speakers.

#### I. PURPOSE

It is the intent of the Governing Board to conduct all business in an open and transparent manner. This is accomplished through public access to the business of the Board, as well as opportunities for the public to provide input for consideration by the Governing Board. This policy is intended to supplement, not supplant, the Open Meeting Law outlined in Louisiana state statute.

#### II. **DEFINITIONS**

- A. Meeting- A meeting is defined as:
  - 1. The convening of members of the Governing Board for the purpose of conducting official board business, either formally or informally, whether it is discussion of matters before the board or if action is taken, and;
    - a. A majority (quorum) of the Governing Body is present.
    - b. A majority (quorum) of the Committee of the Board.
  - Vacant positions must be counted in determining a quorum and will not reduce the number of members required to be present to conduct business.
  - 3. Meetings by telephone or video conferencing qualifies as a convening of Governing Board members if conditions in Section II.A.1 and II.A.1.a apply.
  - 4. A chance or social gathering of a majority of the Governing Board does not constitute a meeting, provided discussions do not include Governing Board business.

#### III. POLICY

- A. Public Notice of Meetings
  - 1. The Board Chair is responsible for public meeting notification.
  - 2. Every meeting notice must include the time, date, place, and subject matter of the meeting.

- a. An agenda with details on each item to be discussed should be included in the notice to provide the public with enough information to make an informed decision whether to attend.
- b. If a closed session is on the agenda, the subject matter to be considered must be included.
- Every meeting notice must be given at least 24 hours in advance of the meeting, exclusive of Saturdays, Sundays, and legal holidays.
- 4. Upon unanimous approval of the members present, the Governing Board may take up a matter not on the agenda. Any such matter shall be identified in the motion to take up the matter not on the agenda with reasonable specificity, including the purpose for the addition to the agenda, and entered into the minutes of the meeting.

#### B. Open Session Requirements

- 1. All meetings shall be publicly held in places reasonably accessible to the public, and open to the members of the public at all times.
- 2. All meetings shall be initially convened in open session. All business must be discussed and acted upon in open session, unless one of the exemptions noted in section III.D below apply.
- 3. The Governing Board is required to create and preserve a record of all motions and roll-call votes. Detailed meeting minutes should be taken at each regular board and committee meeting in order to provide the most transparent record of business by the Governing Board.

#### C. Closed Session Requirements

- 1. If a closed session is noticed on the publicly advertised agenda, then it must include the subject matter of the closed session.
  - a. If notice is not provided on the advertised agenda, it does not preclude the Governing Board's ability to go into closed session to discuss an item contained in the original notice.
  - b. The Governing Board must follow the procedure set forth in Louisiana statute before going into closed session. This is outlined in section III.C.2 below.
- 2. Procedure for Convening in Closed Sessions
  - a. Meeting must initially be convened in open session
  - b. The Governing Board must pass a motion, by recorded majority vote, to convene in closed session.



- i. Before the Board votes on the motion, the Board Chair or designee must announce and record in open session the nature of the business to be discussed and the specific statutory exemption, found in Louisiana statute 42.18 to authorize the closed session.
- c. No items not disclosed on the exemption shall be discussed or considered in closed session.
- 3. The Governing Board may admit anyone to the closed session whose presence the board determines is necessary for the consideration of the subject of the closed session.

#### D. Enforcement and Penalties of Open Meeting Law

1. Violation of Louisiana Open Meeting Law is subject to penalties outlined in Louisiana statute R.S: 42.28.

#### E. Public Input at Meetings

- 1. An opportunity for public comment prior to action on the agenda item upon which a vote is to be taken is required by Louisiana state law.
  - a. Comment must be taken immediately prior to each individual vote.
- 2. The board can also choose to set aside time at regular board meetings for public input.
- 3. All public comment will utilize the following procedure:
  - a. Members of the public wishing to speak shall indicate his/her intent in writing or via communication with the Board Chair.
    - i. A sheet to provide the name of speaker and the topic to which they wish to speak shall be present and available to the public at all open meetings. If the meeting is virtual, the Board Chair shall make note of a speaker's name and topic of input.
  - b. The Board Chair or his/her designee shall call on members of the public.
  - c. Each speaker shall be limited to 3 minutes, except as provided for in section III.E.1.e below.
  - d. Any speaker making defamatory, belligerent, or accusatory comments may be denied his/her
     3 minutes of speaking time.
  - e. The public comment period is limited to thirty minutes unless extended by the board chair.
    - i. The board chair may reduce the speaking time allotted to each speaker or refuse to grant all members of the public wishing to speak the opportunity to do so in order to comply with this provision.
