### D. Discuss Long Term Plans

W. Gardner made a motion to open/re-instate a Treasury backed money market account at Fidelity and transfer \$2million from BCSB to fund it.

J. McDonough seconded the motion.

The Foundation holds \$2.5million in cash. C. Fisher noted that \$2million could be deposited into an investment account. Of that \$2million, \$680k is restricted for Ottiwell Replacement and Renewal Fund. Board determined that \$800k should be restricted for Douglass R&R Fund. Remaining deposits are Impact funds from EFF loan proceeds.

Other unrestricted and restricted funds will remain fluid at BCSB.

The committee **VOTED** to approve the motion.
