N. Woodson called a meeting of the board of directors of The Path School to order on Tuesday Mar 19, 2024 at 5:07 PM.

##### C. Approve Minutes

A. Burtner made a motion to approve the minutes from January 2024 Board meeting on 01-16-24.

## II. PATH School Financials

### A. PATH School Financials

Director of Operations, Theo Brannum, reviewed SY' 24 Statement of Activity and Actuals vs. Budget, and ESSER funds.

March 18, 2024 - \$4.2 mil

- **189** Days Cash on Hand; FY'24 goal is 70.
- ESSER 3 funds remaining: \$452,000 (included in budget for SY'24)
  - Meeting with Path Executive Team to determine how to spend additional funds.
- School Budget Allocation: 7.5 million
  - Left to spend: \$1.8 million
  - Biggest Line Items (GL):
    - Elementary Education - All classroom expenses
    - Office of the Principal - Everything outside of the classroom

## III. School Presentations

### A. School Leader Presentation

- School Mission, Vision, and Values shared.
- SY' 24 School Goals:
  - Attendance:
    - Average Daily Attendance (ADA): **95%**
  - Academic:
    - **18%** of Scholars will pass ILEARN ELA
    - **16%** of Scholars will pass ILEARN Math
    - **60%** of 3rd Grade Scholars will pass IREAD by Summer '24
  - Multilingual Learners (ML):
    - **25%** of ML Scholars will reach their proficiency growth goal on ACCESS '24
    - **80%** of ML Scholars will demonstrate growth on WIDA ACCESS from '23 to '24
- Enrollment/Attendance as of **3/17/24**:
  - Attendance: 636; budgeted for 500
    - 6th grade is highest

- Grade level, demographics, ELL, and Excel specific data shared.
- ADA: 90.2% as of 3/17/24
  - Kindergarten, 1st, and 8th is lowest
- Staffing:
  - 7 Resignations - no change since January
  - 8 New Hires - 1 new since January

- Approved - \$300,000 for planning purposes for SY'24, then \$3 million per year for 3 years starting in SY'25

- Focus on: Home visits, phonics intervention, tutoring services in ELA & Math plan

- **New Indiana Laws:**

- Senate Bill 1:

- Enforces holding back 3rd graders who fail IREAD-3.
- Requires 2nd graders sit for the test starting next school year while also offering summer school courses to students who are struggling to read or are at risk of failing IREAD exam.

- Senate Bill 282: Aims to cut down truancy or unexcused absences.

- Requires schools to intervene early & hold parent meetings in elementary students miss more than 5 days without an excuse.

- Senate Bill 185: Requires school create a policy prohibiting cell phones during instructional time.

- **Contracts, MOUS, and Agreements SY 23-24**

- Reviewed, no changes.
