Alternative Placement Schools:

Northwood Academy Charter School seeks to ensure that all of its students with disabilities be included in a general education environment with nondisabled peers to the maximum extent possible. The consideration for the removal of students with a disability from the general education environment only occurs if the nature or severity of the disability or disabilities are as such that education in the general education classroom, with the use of supplementary aids and services, cannot be achieved satisfactorily, which is where NACS find itself with seven of the students enrolled.

The Least Restrictive Environment Placement for these students was taken into account using the following four factors:

- 1.) The content of our students' IEP;
- 2.) The LRE requirements;
- 3.) The likelihood that the placement option will provide a reasonably high probability of assisting our students to attain their annual goals; and
- 4.) The consideration of any potentially harmful effects that the placement option might have on our students or on the quality of services that our students need.

Due to the intensity of the content of the students' IEPs and the lack of services and supports for the students in need of full-time placement, the following students are being considered for APS:

- 1. 1st Grade
- 2. Kindergarten
- 3. Kindergarten
- 4. 5th Grade?

Currently, there are four NACS students within APS:

- 1. 4th Grade (Fairwold: \$54,062.64)
- 2. 4th Grade (Greentree: \$57,860.19)
