II. Advancement

A. Arts for Learning, Third Space

Third Space Installation Project

- P. Gurthie discussed the Third Space partnership with Arts for Learning.
- Local artists create original works of art to be installed in schools throughout the city of Indianapolis.
- P. Guthrie will request the installation project for fall 2019.

Marketing

- K. Feeney-Caito discussed marketing opportunities to promote the project.
- There will be a final reveal and presentation to the public at the end of the project.
 - P. Guthrie would like to invite the media and political figures to the event.

B. Fundraising Ideas- Big Ideas

Holiday Assistance Program

- P. Guthrie discussed having a Christmas in July themed fundraiser for the Holiday Assistance Program. Edison will begin accepting donations from the public in summer 2019.
