- Finance Updates
 - Budget Hearing
 - Enrollment 284
 - Currently 70 students short
 - 51 in progress
 - Openings 5-7 and k-1, 2-3 is full
 - Stopped enrolling grades 2,3,4
 - Rental expenses for modulars - finish 2024
 - Enrollment over the years
 - Under enrollment target each year
 - We can hold maximum 270 students with modulars
 - Middle School
 - Starting a basketball program
 - 3 SCSC schools closing (1 MS & 2 Elementary)
 - ED connecting to board member and school leader
 - Schools identified us as a preferred school
 - Targeted middle school family
 - Evidence shows when families leave they often want to return
 - Rebranding
 - Expenses
 - Personnel expense increasing
 - Higher curriculum and school costs
 - Will be contracting our social worker
 - SEL Counselor working with at risk group
 - School social worker support students with IEP
 - Occupational therapy, speech therapy
 - We haven't given any new vouches to Walk of Life
 - Biggest cost - facilities

- Will see reduction in expense if we transition out of modulars in Sept
- Grant Opportunities
- Fundraiser and back to school things
- Small boost in enrollment #s when we build excitement - the school is coming
- Currently 2 security (day and night)
 - We won't need night time security when we move into the building
 - We will have security alarms in the school
- Biggest Concern
 - Cash Flow
 - Cash Flow aft the Oct QBE count
 - High facilities cost due to modulars at beginning of the year strain on cashflow
- Fundraising
 - Auction - what would you like to sponsor?
 - Juneteenth Fundraiser
 - Tie it to our new building
 - Eric - Treasurer
