## PURPOSE

- This Agreement is entered into for the following reasons:

  - 2. \_\_\_\_The virtual class will be an 8 hour group class that will be divided into four 2 hour sessions.
  - 3. \_\_\_\_\_There will be a minimum of of 5 and a maximum of 15 students allotted in each virtual class.
  - 4. \_\_\_\_Topics of this class include acrylic foundation, application, & shaping.
  - 5. \_\_\_\_The cost of the group class is \$888 per student, plus the shipping costs per student kit.

## **RESPONSIBILITIES OF THE PARTIES**

- 1. \_\_\_\_The Nail Academy is responsible for providing Nail industry education & mentorship.
- 2. \_\_\_\_The Nail Academy will provide a Fall & Spring Beginner Course & A Spring Intermediate Course.
- 3. \_\_\_\_The Fall class dates include: 10/3, 10/10, 10/17, 10/24, and 10/31 (make up day).
- 4. \_\_\_\_\_The Spring class dates include: 3/5, 3/12, 3/19, 3/26, and 4/2 (make up day).
- 5. \_Reach Cyber School is responsible for covering the class expenses.
- 6. Private virtual classes & additional education is available upon request.

- This Agreement contains the entire agreement and understanding among the Parties hereto with respect to the subject matter hereof, and supersedes all prior agreements, understandings, inducements and conditions, express or implied, oral or written, of any nature whatsoever with respect to the subject matter hereof. The express terms hereof control and supersede any course of performance and/or usage of the trade inconsistent with any of the terms hereof.

#### **REPRESENTATION AND WARRANTIES**

- The Parties agree and disclose that they are authorized fully for entering this Agreement. Both Parties' performances and obligations are not to violate the rights of any third party or else violate other, if any, agreements made between them and/or any other organization, person, business or law/governmental regulation.

#### **LIMITATION OF LIABILITY**

- Under no circumstances will either party be liable for any indirect, special, consequential, or punitive damages (including lost profits) arising out of or relating to this Agreement or the transactions it contemplates (whether for breach of contract, tort, negligence, or other form of action) in case such is not related to the direct result of one Party's negligence or breach.

#### **SEVERABILITY**

- In an event where any provision of this Agreement is found to be void and unenforceable by a court of competent jurisdiction, then the remaining provisions will remain to be enforced in accordance with the Parties' intention.
