- The CFO highlighted the major changes from the 2nd Interim budget to Unaudited Actuals:
  - Government revenues increased by approximately \$320,000
  - Earned interest about \$50,000
  - Decreased JRSF contributions by about \$1,00,000
  - Decreased total expenditures by about \$2,200,000
- The committee recommended the FY'24 Unaudited Actuals to the MWA Board for approval.
