

## Focus Area 1: Student Outcomes

## **BOY** Assessments

Since SY 2022-23, students early on grade or better BOY on i-Ready has improved from 20% to 23% in ELA, and from 14% to 19% in math, with improvement at both schools.

- At the elementary school, Students three or more grade levels behind decreased in both Math and ELA, while middle school rates remained similar at around 50% and 36%.
- Grades 3 and 4 saw the most significant positive movement, with double digit and near double digit changes in students early on grade or better or students three or more grades behind.
- IEP, MLL, and At-Risk students have continued to see the lowest levels of growth at the ES in both subjects; at the MS IEP and At-Risk student growth outpaced overall growth in ELA, but was slower in Math.
- IEP and MLL students in the MS continue to face significant challenges; over 80% of IEP students are 3 or more grade levels behind in both subjects, and over 80% of MLL students are in ELA.

## At the high school, just under 50% of students scored at the 40th percentile or above in ELA and Math, with just over 1/3rd scoring below the 25th percentile.

- Course level achievement varied significantly, with 70%+ of students in advanced courses scoring above the 60th percentile.
- While significant gaps exist between IEP and MLL students and their peers, differences between At-Risk and non At-Risk achievement are significantly smaller at the HS than other schools.

#### At the elementary school, new Acadience assessment suggests around ~45% of students in ELA and Math are at benchmark or above.

- Acadience DIBELS shows relatively stable scores with MClass Dibels, whereas math assessments vary significantly and may not be comparable year over year.
- While students at benchmark on DIBELS BOY drops from 50% to 47% from SY 2023-24, most grades see positive improvement from SY 2022-23.
- Grades 4 and 5, and IEP, MLL, At-Risk and Black student subgroups see declining % at benchmark.

#### **Initial Grade Level Highlights**

ELA

- Grades 2, 3, and 4 saw improvements to students early on grade or above by 9pts, 14pts, and 15pts respectively from SY 2022-23 on i-Ready.
- IEP students early on grade or above at the MS improved by 8pts from SY 2022-23 on i-Ready.

#### Math


- Students three grade levels behind or more between grades 3 and 5 dropped by 10 pts from 39% to 29% from SY 2022-23 on i-Ready. Grade 4 saw a 25pt drop.
- Grades 3 and 7 each saw a significant increase in students early on grade or better with 17pt and 9pt increases respectively from SY 2022-23 on i-Ready.
- Students early on grade or better at the ES who were not IEP, MLL, or At-Risk saw a 17pt increase from SY 2022-23. Powered by BoardOnTrack



## BOY i-Ready Level Distribution Sees Relatively Little Change from SY 2023-24 to SY 2024-25


#### **BOY ELA Level Distribution**




#### **BOY Math Level Distribution**

#### Math Percentile Distribution





#### **ELA Percentile Distribution**







# Q1 Financial Updates

- Revenue increased \$614k from budget due mainly to our sweep account/ investments and higher enrollment.
- Expenses decreased \$267k due mainly to our staffing vacancies and salary shifts.
- Our change in projected cash on hand in FY25 increased \$683k.
- Our end-of-year cash projection increased to \$3.5M from budget due mainly to the \$2.8M higher FY24 close.
