E. Board Development: Updates from Rosewood Strategies

Rosewood provided updates on various facility location options:

- Recommended submitting a letter of intent to NC-SECU to allow for further exploration of the location on Hillsborough St.

- Rosewood continues to work with City staff regarding a traffic study, building height restrictions and permitting issues. Also discussed potential loan options and details.

A strong DEI statement:

Exploris Process:

- At a staff meeting last spring, we studied the purposes of an equity statement for a corporation and read through several examples of effective statements from well known companies like Adobe, Apple, P&G, Lego, and others
- All staff participated in creating notes about what they would like to see included in a statement for Exploris
- Based on those notes, Deb crafted a few versions, which were then shared with Kaizen at the Kaizen retreat for input
- Then based on that feedback, 3 final versions were written and once again shared for input.
- Based on those final notes, we offer this version for Board review

Campus Updates

- Exploris enjoyed Fall Break from Sept. 30th through October 4th and held a teacher workday on October 7th, with an expectation of time on campus co-planning.
- PLC meetings have been focused on reviewing core instruction and differentiated instruction based on data and continuing conversations around norming behavior expectations and reporting in Jumprope.
- Staff Meetings and PD sessions have been focused on the vertical alignment of curriculum.
- Admin, EC, and the Student Support teams have been working on Reporting Requirements for Indicator 11, which falls under Child Find requirements to complete the EC referral process within the 90-day timeline. That process includes the formal steps of referral, evaluation, and eligibility determination.
- Danielle Johnson-Webb from Peaceful Schools led an affinity group conversation on Wed. October 16th for our staff of color. This is part of our ongoing work based on the EID audit last spring and our focus on creating a community of belonging.
- 6th grade held a crew day event at Umstead Park where the team spent the day outside with assorted science activities
- The SIP team has been meeting to polish the draft for the new School Improvement Plan. We have a few more meetings, after which we will present the updated version to Kaizen.
- The 7th grade was able to reschedule their Charlotte trip for Nov. 8th. (The original date was canceled because of the hurricane.)
- On Friday, October 18th, Alexandra's crew went to the Duke Marine Lab in Beaufort to learn about citizen science involving plastic pollution in stormwater runoff. They participated in a beach clean-up and created marine debris art to spread awareness of our ongoing battle against plastics in our oceans. The idea was to introduce students to real-world science involving environmental issues that they can directly affect and use this knowledge and motivation to make a positive change in our local watershed.
- The Student Services Team has been completing the Social Emotional Learning Screener and the Say Something training with each grade level. This gives us data on how our students are experiencing school and handling stress and also provides an essential outlet and anonymous system for students to report anything that might be of concern related to anxiety, self-harm, bullying, or threats of violence against the school.

Community Events

- Our Student Services Team held their monthly Coffee with Counselors event at Transfer Food Hall on October 9th. This is an open opportunity for families to periodically stop by and ask questions or share ideas and concerns with our student support team.
- Exploris is partnered with two schools in western NC that were affected by Hurricane Helene. Throughout the month of October, we are collecting gift cards and small treat boxes and gathering handwritten notes, cards, and drawings to deliver to our sister schools. Everyone in the community is invited to share in this outreach.
- Spirit Week is October 21-25th and culminates in our annual Fall Festival on Friday, Oct. 25th
- Our October Family Connections event is the High School Information Night, presented by Michelle Duncan and Deb Brown, geared especially towards helping 8th grade families understand their high school choices and the application process for all the different programs.
