Campus Updates

- The ADP Rollout will occur soon. This tracking system will give employees more direct access to and accurate reporting on their leave and other benefits.
- Middle School staged a mock election on Nov. 4th after student members of the America 250
 project visited classrooms to describe the election process and highlight the portfolios of
 candidates in national, state, and local races from a nonpartisan perspective.
- Professional Learning Community (PLC) work has focused on updating data and intervention
 plans, documentation norms for behavior, our code of conduct, and using the Jumprope reporting
 system.
- The Middle School, led by Michelle Parkerson, has completed the in-person part of our Crucial Conversations training. Teachers are still working on the asynchronous assignments. The Elementary staff will start their in-person sessions in February.
- We appreciate the work of Emily Vlokjan-Reece, the new PTO chair of Facilities, who has been spearheading repairs, new furniture, and updates on both campuses
- Student Leadership Retreat:
 - Two students from each middle school grade attended a district workshop on leadership through Peaceful Schools; another day will be held in the spring
 - Prepping to form a student Kaizen team that can help provide student voice and action on things like:
 - campus beautification
 - surveys
 - clubs and extracurriculars
 - assorted school decisions
- Peer Advocates has resumed
 - completed an all-day training
 - o will be taste-testing new lunches for a potential switch in our lunch programming
- Mid-year benchmark testing will begin in January. This data from MAP Growth assessments
 provides updates on student progress and can help guide core instruction and identify students
 who may need intervention services.
- Achievement reports, Intervention Progress Reports, and EC Progress Reports were all emailed to families on Dec. 6th.
- The Director team launched a winter update of the Trust Survey we gave last January to get benchmark data to compare to the initial data for school climate.
- The SIP sub-committee for Kaizen has been meeting regularly to work on detailed aspects of the School Improvement Plan.
- The Kaizen team will work on the FAM-S, an annual survey measurement of the MTSS process in schools.

- We have been working with the Department of Public Instruction to secure Special Reserve funding for a few new students who require more extensive services, such as 1:1 support.
- We are discussing ways to build capacity in our aftercare programs, including additional help and opportunities for academic tutoring, club-style activities, etc.

Community Events

- Conferences were held on both campuses on Nov. 1st and 5th. In elementary school, parent-teacher conferences are held in the first trimester, and in middle school, these are student-led portfolio conferences. All conferences in the second and third trimesters are student-led conferences.
- On Nov. 22nd, the eighth grade held their Water Gallery Walk, a culminating presentation of the fall expedition around science and social studies standards and service learning projects.
- We are in recruitment season!
 - o Tours have begun, led by our Student Ambassadors, once a week on each campus.
 - The Directors held an information session and it was recorded and posted online.
 - The lottery is open and all can apply online through our website
 - We are running ad campaigns on social media and boosting some posts; putting more of our resources towards these social media ads bc our metrics suggest they have been more impactful in the past than some other avenues
 - We are advertising on streaming audio and website banner ads
- The Hurricane Relief project adopted two schools in Western NC and collected gift cards for teachers and families
- The National Theatre for Children performed at the Elementary Campus on Nov. 19th
- The Student Service Team coordinated our annual Angel Tree project to provide holiday gifts and food to families within the Exploris community who may not otherwise have access to a holiday celebration with gifts.
- Cross Country finished strong with several wins and multiple personal records, as well as participation in some community 5K runs.
- On November 20th we held a staff social to honor Cori Greer-Banks and wish her well in her new position at Carolina Connect at UNC.
- On December 5th, the 7th grade held a Body Systems presentations at Roomah, which was the culminating event for the fall Expedition project.
- The annual Exploris recitation of the Universal Declaration of Human Rights was held on Dec.
 17th. 7th and 8th grade both participated because the event is transitioning to a 7th grade project and 8th grade will take on Constitution Day, to better line up with their social studies curriculum of world history in 7th grade and American history in 8th grade.
- The PTO held a Winter Movie Night on Friday, Dec. 13th.
