Per Arizona Revised Statutes (ARS) 15-905, not later than July 5 of each year or not later than the publication of notice of the public hearing and board meeting as required by this section, the governing board of each school district shall prepare and furnish to the superintendent of public instruction and the county school superintendent, unless waived by the county school superintendent, a proposed budget in an electronic format for the budget year, which shall contain the information and be in the form as

provided by the department of education. The proposed budget shall include the following:			

1. The total amount of revenue from all sources that was necessary to meet the school district's budget for the current year.
2. The total amount of revenue by source that will be necessary to meet the proposed budget of the school district, excluding property taxes. The governing board shall prepare the proposed budget and a summary of the proposed budget.
