Started with a \$430,000 transfer (still \$170,000 above the goal)

Needs:

- Custodial services high school
- Principal

Additonal revenue investigation:

- CTE Credits
- ESSR Funds (custodial, software, high school teacher, cleaning supplies) (Possible \$130,000)
- More high school students
- Grants (textbooks)

Actions:

Reduced the contracting Fees to \$40,000 for the year (Saved \$53,000)
Investigate the text book fees.

Take a preliminary budget to the board in June.
