A.

Improving family and community involvement through volunteer opportunities and effective communication.

Discussion and planning for upcoming Family Engagement events was held with the following possibilities evolving as opportunities for the Student Excellence Committee to support:

B. Improve school culture and climate by increasing opportunities for faculty and staff to feel appreciated and valued as partners in the education of students.

R. Allen and D. Hahn shared a variety of options for engaging families to support the appreciation of faculty and staff on both school campuses. J. O'Donoghue mentioned the addition of Teacher Appreciation events on alternating months in conjunction with the current efforts of K. Mixson and D. Ward on their respective campuses. D.
