Pivots Expected

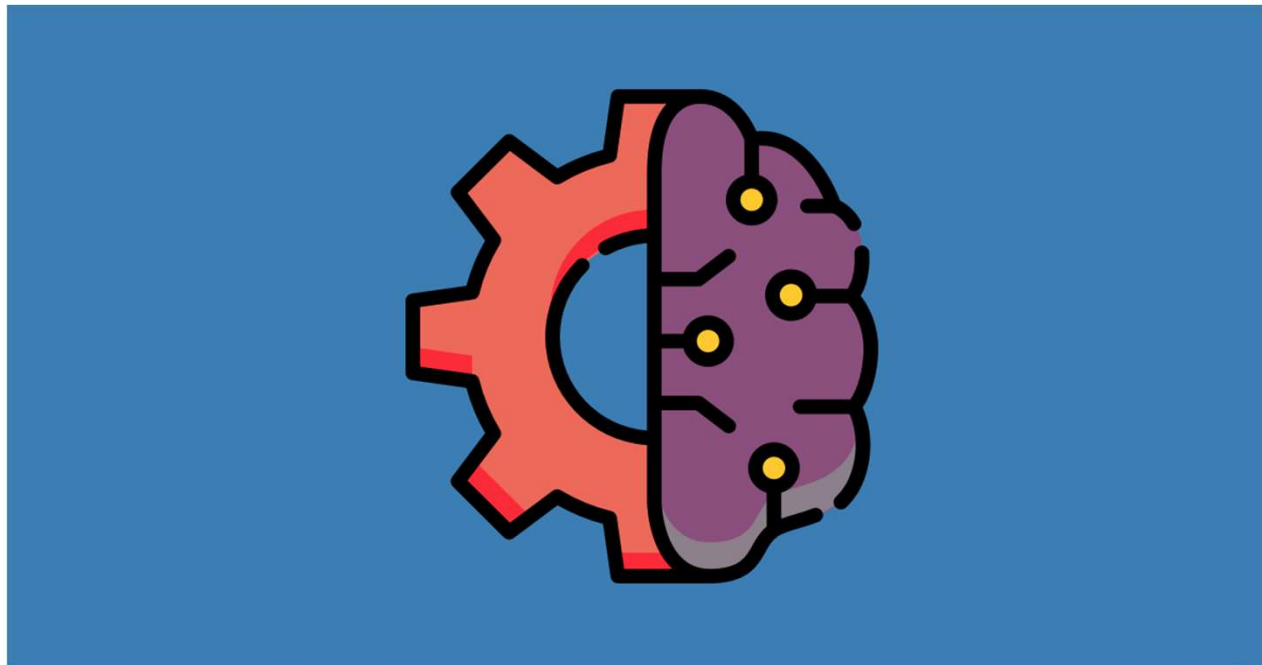


With the rapidly evolving trajectory of the virus and the state's pending reopening, the Hybrid Committees have been poised to plan for reopening of any form. We are grounded in our anchors of **community, equity, joy, excellence and innovation**. We are having rich conversations about how these play out in a return to in-person school.

Full Reopening + Distance Learning Option

- ▶ Full reopening = 100% of students who opt in will be able to come every day for a full instructional day
- ▶ Distance learning option = for the 1st semester of 21-22, families who opt out will be offered a full distance learning option
 - ▶ This will be different than our current model
 - ▶ It may be through an independent study model
 - ▶ It may have to be through an external agency
 - ▶ We are not yet certain as to what will be allowed
