### B. Teacher and Staff Professional Development Platform

Teryl explained our desire to move our professional development to an online/hybrid structure.

We looked for something to provide more professional development to paraprofessionals.

We can make specific assignments for individuals as well as whole group.

We determined we would like to purchase for the whole school.

Part of the Digital Teaching and Learning.

Master Teacher platform; \$8,396 for whole school.

Courses can be assigned based on need.

W. Davis made a motion to approve purchase Master Teacher for \$8,396.
