#### II. Comments from Commission Chair

#### A. Comments

Norm reported that Leigh and Brian have agreed to serve on the New School Application Review Team.

Norm provided an update on legislation the Commission will be monitoring:

- Senator Joe Rafferty will sponsor the bill for DFAS administrative changes pertaining to MCSC.
- Senator James Libby will sponsor the bill proposing to increase enrollment limits on virtual schools by 20%.
- Representative Sheila Lyman will sponsor the bill addressing an extension of the insured value factor to charter schools.

#### **IV. Public Comment\***

#### A. Public Comment

Susan Muzzy building principal at Dimensions Academy, Community Regional Charter School reported on several activities and events at CRCS.

- CRCS will be participating in WinterKids, a State of Maine elementary school competition lasting four weeks. They are representing Somerset County and can win up to \$5,000 for their school. As part of this, on January 29th at 6am, the students will be on Channel 8 news doing the morning weather report. Travis Works has forwarded information on the event schedule to the Commission and to Lana.
- For school choice week, they will host a school wide ice fishing event, working on parent and board involvement. They are also holding a contest asking students to write about what school choice means to them and why does CRCS matter.
- To raise awareness of their multiple locations, they will be holding a district wide school dance in Skowhegan.

# A. SY2023-24 Annual Report Review and Discussion with Commissioner Makin \*\*\*Commissioner Makin will join at 2:30\*\*\*

Lana informed the Commission that she and Commissioner Makin met to go over the report in detail prior to the meeting.

Lana summarized the report highlights as follows:

#### Demographics:

- This year there were 2,717 students enrolled in the Charter School portfolio which is an increase from last year but is less than 2% of all Maine students. Schools are meeting their contracted enrollments and have wait lists.
- The Charter School students come from 143 districts and 300 cities, towns and unorganized territories.
- 23% of the students have an IEP and overall, 44% are from economically challenged families while there is variation among schools on this statistic.

Charter School Strengths:

- Student retention and persistence is high which is an improvement from past years.
- Students in 8 of 9 charter schools are meeting expectations for proficiency in reading on the State assessment and are either at or above the state average.
- 6 of 7 schools meet or exceed the State High School Graduation rate goal.
- Seniors in 6 of 7 schools meet or exceed the Community College benchmarks for readiness in math and reading on either the Accuplacer or SAT exams.
- In the annual Panorama survey, family satisfaction is high, scoring in the 90-99% positivity range nationally.

Charter School Areas to Grow

- Math Half the schools are either approaching or not meeting expectations in math, so this is an area of focus for the schools.
- Attendance Half the schools are above the State average for chronic absenteeism, so the schools are also focused on improving this metric.

#### VI. Executive Director/Commission Staff Report

#### A. School Updates

Harpswell Coastal Academy has officially dissolved as a 503(c).

#### **B.** Organizational Updates

Lana reported the staff is on track with activities as presented in the workflow calendar. Tom inquired about the review of differences between public and public charter school requirements for teacher certifications. Lana confirmed this project is on the work plan.

Lana reviewed the detailed timeline for the New School Application Review Process.

Mid-Year Meetings with school administrators and board members have started. The focus of the meetings is on (1) areas where schools are not meeting expectations on the performance framework and (2) progress on the short-term goals discussed in the fall professional development sessions. Reports will be provided in detail to the School Performance Committee and in summary form to the whole Commission in March.

The November Commission meeting conflicts with Veteran's Day on the 11th, so Lana proposed holding the meeting on November 18th. This will be a future agenda item for official action in addition to a vote on whether to hold a July meeting.

### A Lens for Understanding and Evaluating Educational Policy

#### WHY IS THIS LENS IMPORTANT?

1. Educational leaders need to develop conceptual knowledge and skills in analyzing, exploring, thinking about, and acting on the societal and organizational forces that influence educational policy and decision making at all levels of the educational system, as well as within different organizational settings.

2. Educational leaders need to be able to analyze, synthesize and apply research and theory derived from the political and social sciences, educational politics and policy-making literature, and one's own experiential background to problems associated with positions they either currently occupy or aspire to hold.

3. Educational leaders need to be able to demonstrate an understanding of the process by which policies, decisions and actions are made and implemented in educational institutions at school and school district, state, and federal governmental levels.

4. Educational leaders need to be able to apply political frameworks and theories to one's own work setting and institutional environment in order to evaluate policy issues.

#### BACKGROUND

Policy researchers argue that four values: choice, efficiency, quality, and equity are pursued in education policy. What follows is an excerpt from *Culture and Education Policy in the American States* by authors Marshall, Mitchell, and Wirt which explains each of these educational policy values, along with "mechanisms" for implementing them.

#### Chapter 4 - Public Values in the Policy Culture

Suppose you are a legislator who thinks schools should be managed more efficiently, or a teacher union lobbyist who thinks that schools (and teachers) should not be getting less money just because they are located in a poor district. What kind of policy would you push for: higher standards for school buildings, special training for superintendents, higher state definitions of minimums for school curriculum programs? How do policy actors choose a policy mechanism? Is there a defined pattern? Do policy actors use certain mechanisms for certain goals? This chapter identifies such patterns by examining policymakers' values. The most important distinguishing feature of any culture is its system of values. While cultural systems also provide their 'natives' with common ways of perceiving the everyday objects, persons, and events, these common perceptions of concrete events and observable phenomena can be communicated across cultural boundaries. Basic values are not so easily communicated. Aliens seeking to enter a foreign culture must devote considerable time and energy to discovering and understanding the nuances of ordinary activities before they can grasp

the value system and gain access to the culture's underlying structure and meaning. The gap between universal experiences of concrete events and divergent ways of interpreting and evaluating those events is the most common source of cultural conflict. This chapter inquires into the core values of state policy actors. Like ordinary citizens, public policymakers rely on the core values of their culture in forming overall judgments about various proposed courses of action. Cultural norms tell them whether the anticipated activities are morally good or bad, socially important or trivial, politically purposeful or meaningless, personally fulfilling or aimless. This chapter shows policy preferences are shaped by the cultural values embraced by individual policy actors. Moreover, cultures vary from state to state.

To understand how the four core social values shape policy maker behavior, we need to describe how each has its roots in a unique political ideology or philosophy.

#### Choice (or Liberty)

This is arguably the most basic of all American public values. It was the passionate belief of the American Federalists that good government is defined by its ability to preserve freedom of choice for its citizens. This was the bedrock of classical liberalism as formulated by John Locke and John Stuart Mill. It was summed up succinctly by Thomas Jefferson in his declaration, 'That government governs best which governs least. Choice is a difficult value to pursue through governmental action; it seems generally to be supported more by inaction than by positive policy formation. A number of critical choice issues can be identified in current education policy debates, however. Probably the most prominent among them are vouchers and other strategies to allow families to choose among schools for their children. But many strategies for increasing choice are less dramatic and less controversial. Recent choice embracing strategies include alternative school program development, flexibility in local school planning, and greater decentralization of budget and management decisions.

#### Quality (Excellence)

Given the primary role played by choice or liberty in the American political system, positive public policy actions must be justified in terms of their ability to enhance the quality of life for citizens. Indeed, governmental action to provide direct services is defensible only if the quality of the services provided is on the whole at least as good as could be reasonably expected to arise through private action. The argument that government is intrinsically superior to private action in some areas of service has a long and convincing history. In the modern period Rousseau's social contract theory best captured this argument. His theory is based on the proposition that citizens join together in collective action to achieve goals they would be incapable of reaching through private actions and thus enter into a contractual relationship with the State — securing improved life opportunities in exchange for reduced personal liberties. As a practical matter, Americans have believed for about a century that the overall quality of life in this country is substantially increased through a system of free, compulsory mass education. For some the quality improvement is economic, measured by the greater productivity of well-educated workers. For others, the compelling rationale for public education is civic — schools provide an introduction to American culture and prepare responsible citizens. Still others see the benefits of public education in private terms \_ increased personal capacities and expanded sensitivity to culture, language, literature, and the arts. However, the goals of public education are defined, quality is destroyed if schools do not have the resources, the technical capacity, or the will to deliver services effectively. Hence, despite the variety of its ultimate ends, there is broad agreement that quality is an instrumental and immediate public value, one with which to judge school performance and formulate policies aimed at shaping their performance. This instrumental meaning of quality provides the positive basis for policy evaluation and informs strategic thinking about how to improve schools. Strategies for improving quality include increasing money and resources, increasing minimum requirements for teachers and administrators' certification, and increasing the number of courses required in the school curricula.

#### Efficiency (Accountability)

Americans have had an intense love-hate relationship with efficiency as a public policy value since the founding of the Republic. The cruel efficiencies of totalitarian governments are recognized and feared But the productive efficiency of American business and industry are just as frequently held out as the model after which to design public service agencies Moreover, Americans feel a need for an orderly, predictable, and controlled system to contain private and interest group conflicts threatening the social order. Social unrest and the threat of anarchy fade when government provides for the orderly and efficient delivery of public services. It was Thomas Hobbes who used the problem of efficiency and order as the cornerstone of modern political theory. Without government to create efficient order, Hobbes argued, life guickly becomes *'brutish, short and ugly.' For Hobbes, the arbitrariness of efficient governmental authority* is a small price to pay for the resulting security and order which make civilized life possible. In the American experience the efficiency of scientific management (Taylor, 1911) is more often presented as the legitimating reason for expansive governmental authority. But recent conservative political ideologues offer a straightforward embrace of Hobbesian argument in their call for 'law and order' in daily life. As indicated in chapter 1, the embrace of efficiency in education was given a tremendous boost by scientific management theorists during the first three decades of this century (see Callahan, 1962). Regulating school operations in ways intended to keep costs down and order up has been a major concern of policymakers in most states and localities. The strong presumption that expansive and generally centralized governmental authority is the proper means for achieving efficient control has recently come under attack but it remains a core value in most education programs.

#### Equity

Though the very first 'self-evident' truth set forth in the Declaration of Independence is that 'all men are created equal,' Americans have had considerable difficulty embodying this core value in public policies. Nevertheless, equity is a core public value and one which can be powerfully invoked as a basis for creating or changing policy decisions. Karl Marx framed the problem of equity for modern political theory. He argued that inequities in society are a governmental responsibility because private social relationships inevitably exacerbate the problem. In private society, Marx argued, there is a steady accumulation of wealth and privilege in the hands of one social class at the expense of others. Revolutionary warfare is, he asserted, the inevitable consequence of this instability in private social relationships. Hence the government must perform the most important function of interceding in this drift toward private domination by taking action to restore equality of opportunity to all citizens — giving everyone a chance to benefit from economic productivity and to share in the privileges of full citizenship. The Marxist vision of inevitable revolution by disenfranchised groups against the privileged classes has not come to fruition in the United States. Political leaders, perhaps actively understanding Marx's argument, have acted to keep the process from following the natural tendency toward cumulative inequality. Without accepting Marxist theory, policymakers in this country have recognized the importance of preventing alienation and abuse by political elites. As a policy matter, equity is complicated. It is a matter of redress rather than one of address. That is, policymakers cannot decree social equity, they can only create laws and social programs that relieve the effects of inequity after it has been identified. The need for governmental action cannot be recognized until some identifiable inequity has been shown to be serious and in need of remedy. Then action is only justified to the extent necessary to eliminate the identified inequity. In schools educators have been asked to treat equity problems on two levels: (1) elimination of inequality of educational opportunities within and across all school programs; and (2) the provision of special educational resources to disadvantaged and disabled children to enable them to achieve greater equity in society after they leave the school.

#### POLICY MECHANISMS

Individual policymakers tend to specialize in one or more of these domains. Moreover, decisions in one domain tend to be made with little concern for those involving the other mechanisms. The following operational definitions serve to distinguish among these seven basic state policy mechanisms in education:

1 School finance: controlling how education funds are distributed and how human and fiscal resources are allocated to the schools;

2 School personnel training and certification: controlling the conditions for getting or keeping various jobs in the school system;

3 Student testing and assessment: fixing the timing and consequences of testing, including subjects covered and the distribution of test data

4 School program definition: controlling program planning and accreditation or otherwise specifying what schools must teach and how long they must teach it;

5 School organization and governance: the assignment of authority and responsibility to various groups and individuals;

6 Curriculum materials: controlling the development and/or selection of textbooks and other instructional materials;

7 School buildings and facilities: determination of architecture, placement, and maintenance for buildings and other school facilities.

Within each of these seven domains policy debates and decisions tend to focus on a relatively small number of competing approaches to the formulation of specific policies or programs.

A PRACTICE FOR UNDERSTANDING AND EVALUATING POLICY ISSUES

One practice school leaders can use to increase their knowledge in understanding and evaluating policy is for school leaders to identify a policy they have enacted (or may be enacted in the future) by their organization and analyze it through the lens of the educational values of Choice, Quality, Efficiency and Equity. Questions to discuss include: What value(s) does this policy try to address? What types of conflicts will be created with other values?
