Summary of the activities of the board or commission related to accomplishing its mission in 2023:

In 2023, the Maine Charter School Commission continued its monitoring and oversight of Maine's public charter schools. With the vote to non-renew Harpswell Coastal Academy's charter contract last fall, much time was spent partnering with school staff and board members to ensure a successful closure and a smooth transition for students, families, and staff effected by the closure. In March, the Commission hired a new Executive Director who - along with an Operations Director and Administrative Assistant - carries out the daily work of the Commission. Two new members were appointed to the Commission and time was spent on onboarding/orientation. Finally, the Commission voted to renew Maine Connections Academy's charter contract for 5 years.
