"Maine Connections Academy, Scarborough. At Maine Connections Academy, 98% of students scored at or above the proficient level for math, and 98% scored at or above that level for reading. The student-teacher ratio is 22:1."

C. State Released Chronic Absenteeism

- State average was 27.3% for last year.
- Four of the charters are below the average (MCA, MEVA, ACADIA, Maine Arts), and the other five are above; something to keep working at.
