### **Low-Performing Students Block Grant Plan**

Feather River Charter Schools LPSBG plan consisted of using a data driven decision making approach to identify the students who qualified for LPSBG to identify their specific areas of individualized support needs for their individualized learning plan. FRCS has implemented an online direct instruction platform that consists of four-to-six-week direct instruction, intervention courses for mathematics, reading, and writing, as well as study skills in an effort to afford our students with the critical thinking skills to be successful in their college and career pathways. Additionally, we offered three (3) separate, three (3) week cycles of study skills intervention which included direct instruction on test taking skills to support students who were performing below standards on our interim benchmark assessments.

FRCS also developed a Junior High Virtual Academy (JHVA) and High School Virtual Academy (HSVA) in the 2020-21 school year to support students. Both programs were developed to teach live online instruction providing standards aligned courses by credentialed teachers.

Our LCAP plan, Goal 1 aligns with our LPSBG plan as FRCS will continue to develop plans and utilize data to strengthen student achievement for all students. This strategy of implementing the utilization of schoolwide data not only benefited our targeted low performing students but schoolwide as well. FRCS students overall improved by 4.3 Distance from Standard Points (DFS) on the Academic Indicator English Language Arts for the most recent dashboard release. Another area of improvement overall over the two years (since the eligibility for LPSBG) was that our students who met or exceeded state standards on ELA increased by 7%. Due to the pandemic all state testing was suspended for the 2019-20 and 2020-21 school year. To proactively utilize data, we used our interim benchmark assessments which are aligned to the state standards to monitor our student's progress three times a year. Initially when we qualified for LPSBG we had 65 students who qualified and of those 65 students 75% have improved and have been exempt from qualifying for the grant. Though that is a great improvement, we are continuously striving to improve our students' academic achievement, meet state standards, and help support students based on their individualized learning needs while providing professional learning on the importance and impact of state testing.
