INSURANCE COVERAGE

Cables & Chips, Inc. will provide proof of all necessary insurance requirements prior to the commencement of work.

TERMS & CONDITIONS

-This quote is based on a new construction buildout with all necessary conduits, furniture feeds, floor chops, core-drills, etc., furnished and installed by others. This is not to be done by Cables & Chips.

-All modifications will be done so with Change Orders. Customer will be responsible for signing Change Orders prior to C&C proceeding with work.

-All structures (conduits, flex, floor-chops, etc) are to be furnished and installed by others prior to the cabling. All work that is related to system pathways are to be furnished and installed by others. All conduits must have pull string.

-All rack/cabine/ladder rack/cable tray grounding and bonding is EXCLUDED from this quote.

-C&C requires free and unobstructed access to all areas of work covered by this proposal throughout the workday for the duration of the project.

-Pricing is based on straight time labor ONLY. Idle time incurred by C&C staff due to factors beyond our control will be invoiced at current labor rates.

-C&C will place rubbish and flatten cardboard to a location designated on the same floor for removal by others.

-C&C will NOT be responsible for patching/painting or any costs associated with patching/painting holes that are made in order to run the cables

-All data patching & voice cross connects are EXCLUDED from this quote.

-C&C requires a secure staging area for all materials and equipment.
