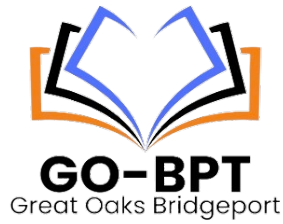

HVAC Update-

- After an assessment from Main Enterprise, we found that several of the fans on the rooftop units needed to be replaced. Based on this we have made a decision to have half days until the rest of the school year.
