## BACKGROUND

Assembly Bill (AB) 86 (Chapter 48, Statutes of 2013), Section 85, appropriates \$1.25 billion (approximately \$200 per prior year enrollment) in the 2013-2014 school year to support the integration of academic content standards in instruction adopted pursuant to various *Education Code* sections.

CCSS implementation funds can be expended for any of the following purposes:

- Professional development for teachers, administrators, and paraprofessional educators or other classified employees involved in the direct instruction of pupils that is aligned to the academic content standards adopted
- Instructional materials aligned to the academic content standards including, but not limited to, supplemental instructional materials
- Integration of these academic content standards through technologybased instruction for purposes of improving the academic performance of pupils, including, but not necessarily limited to, expenditures necessary to support the administration of computer-based assessments and provide high-speed, high-bandwidth Internet connectivity for the purpose of administration of computer-based assessments

As a condition of receiving CCSS implementation funds, the District, is required to:

- Develop and adopt a plan delineating how the CCSS implementation funds will be spent. The plan must be explained in a public meeting of the governing board of the school district and then be adopted in a subsequent public meeting
- Report detailed expenditure information to the California Department of Education (CDE) on or before July 1, 2015, including, but not limited to,

specific purchases made and the number of teachers, administrators, or paraprofessional educators that received professional development

The funds may be spent in 2013-14 and 2014-15.

## **CURRENT CONSIDERATIONS:**

ECRCHS's goal is to administer the common core state assessments through computers and is in need of building the necessary infrastructure and devices, as well as providing professional development for the use of these devices.

## Common Core State Standards Spending Plan For the 2013-14 and 2014-15 Fiscal Years

## <u>Background</u>

The enacted State Budget for 2013-14 provides one-time funds to local educational agencies to support the activities required to implement the federal Common Core State Standards that California has adopted. These new standards are required to be in place for the 2014-15 academic year. There are a number of activities that we have already undertaken, and continue to undertake, to prepare for this implementation. This new funding is provided specifically to support these activities:

- Professional Development for certificated and classified employees involved in the direct instruction of pupils using the Common Core State Standards
- □ Instructional materials and supplemental instructional materials aligned to the Common Core State Standards
- □ Technology equipment and infrastructure to provide technology-based instruction using Common Core State Standards and to implement computer-based student assessments

The funds must be spent by July 1, 2015. As a condition of receiving the funds, a spending plan for the funds must be presented at a public meeting of the governing board and then approved at a subsequent public meeting of the governing board. What follows is the proposed spending plan for the Common Core State Standards funding that we will be receiving.

## <u>Funding</u>

The estimated amount of one-time funds to be received for this purpose is \$756,825.

## <u>Uses</u>

We plan to use the funds during 2013-14 and 2014-15 in the following manner:

- Provide in-services for certificated and classified classroom staff on the new content standards and to develop curriculum aligned to the new standards
- □ Adopt and purchase current standards-aligned instructional materials for English language arts and mathematics
- □ Upgrade the technology infrastructure to provide Internet access and meet Smarter Balanced Technology Strategy Framework and System Requirements Specifications
- □ Purchase additional computers and software for technology-based instruction
- Etc.

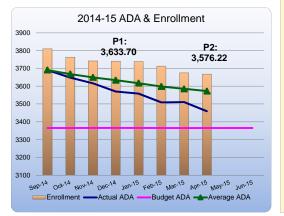

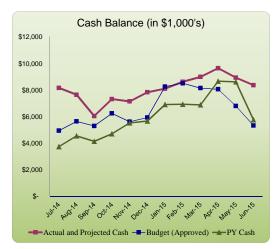
#### Year-End June 30, 2015 Forecast

- ECRCHS is projected to have a 29% cash reserve at year-end. Not including cash held in investments and amount due to Student Group.
- A Debt Equity Ratio (ratio of total debt to equity/net assets) of less than 1 demonstrates fiscal soundness and prudence. ECRCHS has zero current debt and is forecasted to have zero current and long term debt at fiscal year-end.
- CALPADS Fall 1 Certified Unduplicated FRPM / EL / Foster Youth Count: 772 and includes 692 FRPM, 105 EL, 4 Foster Youth
- Forecast assumes Certified P1 LAUSD Unduplicated Count of 78.54% as the District of Residence cap for LCFF Grant Funding. GCS Budget previously assumed 77%.

## Net Income

The FY14-15 forecasted net-income is \$4.3MM compared to \$2.6MM in the board approved budget.

## **Balance Sheet**

### Assets

- The combined cash and investments is \$12MM
- \$4MM of cash is held in Charles Schwab investment accounts.
- \$230K of cash is held in Wells Fargo and California Credit Union Certificate of Deposit accounts.

## Additional Asset Detail

• Accounts Receivable balance is zero which is down 100% from the June 30 prior year \$4.2MM government per pupil receivables.

## Liabilties

Liabilities Detail

- \$8K in Accounts Payable balance, including payroll liabilities.
- \$454K in Due to ASB.
- \$445K in Due to Grantor, which represents a duplicate payment of the prior year Supplemental Block Grant. This amount will be withheld from future apportionments.
- Debt balance is zero. ECR has no current or long term debt liabilities.

## **Income Statement**

### Revenue

Forecasted revenue for FY14-15 is \$33MM, which is \$2.8MM or 9% over budgeted revenues of \$30MM.

**Object Code 8011-8096**: LCFF and In-Lieu of Property Taxes forecast is \$1.4MM above budget due to enrollment being 200 students higher than budget at the end of the P1 attendance period. Student attrition has slowed considerable compared to prior years. The March forecast assumes the reported P2 ADA of 3,572.68.

**Object Code 8181**: Federal Special Education IDEA forecast is \$83K above budget as a result of LAUSD increasing the per pupil rate.

This report will discuss revenue and expenditure variances from the Board-approved budget that are above \$20,000 and 10%.

**Object Code 8599**: Other State revenue is forecasted to be (\$159K) below budget, because \$585K in prior-year Common Core Funding was deferred to 2014-15 vs. the original estimate of \$757K when the budget was developed.

**Object Code 8690**: All Other Local Revenue March actuals are \$887K above budget:

- 1. Foreign Exchange Student fees are \$480K higher than the \$300K budget assumption.
- 2. Student Store Sales and Facility Rental income was not budgeted.

### Expenses

Forecasted expenses for FY14-15 are \$28.7MM, which is \$1.1MM or 12% over budgeted expenditures of \$27.5MM.

**Object Code 1175**: Teacher – Stipends/Extra Duty are trending at \$561K above budget. The monthly run rate is averaging at \$128K per month.

Object Code 2100: Instructional Aide salaries are trending at \$159K above budget.

Object Code 2400: Clerical/Technical/Office salaries are trending at (\$97K) below budget.

Object Code 2900: Other Classified salaries are trending at (\$88K) below budget.

Object Code 3401: Health benefits are trending \$127K above budget.

**Object Code 3601**: Worker's Comp is trending (\$143K) below budget.

**Object Code 4210**: Other Books is forecasted to be \$35K above budget due to the purchase of an online SAT & ACT Prep Curriculum and the monthly trend expense for Other Books.

Object Code 4390: Other Supplies are trending \$328K above budget.

Object Code 5450: General Insurance premiums are \$95K higher than budgeted.

Object Code 5500: Operations and Housekeeping costs are trending \$153K above budget.

**Object Code 5900**: Communications costs are trending \$37K above budget.

**Object Code 6900**: Depreciation Expense is forecasted to be \$102K higher than budget due to the increase in fixed assets in FY13-14 and current year capital expenditures totaling \$513K year-to-date.

### ADA

Budgeted average ADA for FY14-15 is 3,364.90 based on an enrollment of 3,542 and a 95.0% attendance rate. The June 30, 2014, forecast assumes the reported P2 ADA.

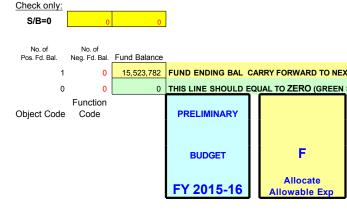
