- 1. They are the President and Secretary, respectively, of El Camino Real Charter High School, a California nonprofit public benefit corporation.
- 2. Article I of the Articles of Incorporation of this Corporation is amended to read as follows:

The name of the Corporation is El Camino Real Alliance.

3. Article II of the Articles of Incorporation of this Corporation is amended to read as follows:

The Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes. The specific purposes for which this Corporation is organized are to manage, operate, guide, direct and promote one or more California public charter schools.

The Corporation is organized and operated exclusively for educational and charitable purposes pursuant to and within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provision of these articles, the Corporation shall not, except to an insubstantial degree, engage in any other activities or exercise of power that do not further the purposes of the Corporation. The Corporation shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- 4. The foregoing amendments of Articles of Incorporation have been duly approved by the Board of Directors.
- 5. The Corporation has no members.

**RE:** El Camino Real Charter High School Request for Material Revision

Dear Mr. Cole-Gutiérrez:

On behalf of El Camino Real Charter High School ("ECRCHS" or the "Charter School"), I am writing to request a material revision of ECRCHS's charter petition. This letter, and the enclosed documents, were prepared consistent with the Los Angeles Unified School District (the "District") Charter Schools Division's ("CSD") Administrative Procedures for Charter School Authorizing ("Administrative Procedures") (revised 9/10/13) and Request for Material Revision Checklist (revised as of the same date).

#### A. RELEVANT BACKGROUND INFORMATION

ECRCHS is seeking a material revision of its charter in order to make important changes to its (1) governance structure and (2) employee job title/description.

#### 1. Governance Structure

ECRCHS is seeking to change the name and specific purpose of the corporation that operates the Charter School, as well as its corporate structure. By filing a Certificate of Amendment of its Articles of Incorporation with the Secretary of State, ECRCHS has changed its corporate name from El Camino Real Charter High School to El Camino Real Alliance ("ECRA") and revised its specific purpose to allow for operation of one or more California public charter schools. While the corporate name and specific purpose changes are not explicitly identified as material revisions in the Administrative Procedures, we want to be sure to point them out in this request. The filed-endorsed Certificate of Amendment is attached as Exhibit A.

Upon approval of its material revision, ECRCHS would be operated by ECRA. The reason for this requested change is that ECRA intends to function in the manner of other Charter Management Organizations ("CMO"), operating one or more charter schools and providing a

centralized administrative and operational structure to those charter schools. As the District knows, ECRA has submitted two charter petitions to operate new independent charter schools.

#### 2. Employee Job Title/Description

The Charter School seeks to change the title and job description of its school leader. Currently, that title is Principal, and the Charter would like to change to Executive Director. The job description for this position would be expanded to include supervisory oversight over Charter School Directors at the ECRA proposed-new independent charter schools. The reason for this change is to ensure the efficient, consistent, and cost-effective administration of all charter schools operated by ECRA. The employment qualifications, which are the only legally required component of Element 5 of charter petitions, are not projected to change.

#### **B.** ANALYSIS AND DISCUSSION

#### 1. Governance Structure

The Charter School has carefully studied and considered the potential for seamless administration and economies of scale in operating more than one conversion or start-up charter school in the West Hills area of Los Angeles. In its four-plus years of operation as a conversion comprehensive high school, ECRCHS has maintained or increased the academic and athletic stature of El Camino Real High School; has amassed a very conservative approximately 30% budgetary reserve; has acquired new property and programs to support expansion; and has always received clean annual independent financial audits.

We believe that this proposal is educationally sound because ECRCHS will transition its experience and best practices to ECRA, which will expand upon that strong base. The ECRCHS site leadership includes a Principal (which would transition to Executive Director upon approval of this material revision), Chief Business Officer, 5 Assistant Principals (two of whom would have roles with other ECRA schools), Chief Technology Officer, and 3 Directors. All of these positions, plus the brief listing of major accomplishments above, demonstrate the Charter School's capacity to implement the proposed transition.

#### 2. Employee Job Title/Description

Changing the title and job description of the ECRCHS Principal is educationally sound because it will clearly communicate and delineate this individual's role within the ECRA community. The change will also ensure the efficient, consistent, and cost-effective administration of all charter schools operated by ECRA because all charter schools will, at the highest level, be supervised by the same individual. The Charter School's capacity to implement this proposed change is substantially the same as its capacity to implement the proposed change to the governance structure. The Executive Director will continue to be hired, terminated, and evaluated by the Board of Directors.


#### C. IDENTIFICATION AND DESCRIPTION OF CHANGES

#### 1. Governance Structure

All references in the ECRCHS charter petition to El Camino Real Charter High School <u>as the corporation operating the Charter School</u>, will be revised to read, "El Camino Real Alliance" or "ECRA." As one specific example, Element 4 of the ECRCHS charter petition will include the following language directly after District Required Language:

"El Camino Real Charter High School is a direct-funded, independent charter school operated by El Camino Real Alliance, a California Non-Profit Public Benefit Corporation with a 501(c)(3) tax exempt designation from the IRS."

Additionally, the organizational chart has been updated as follows:



#### 2. Employee Job Title/Description

All references in the ECRCHS charter petition to the Principal as the school leader will be revised to read "Executive Director." As one specific example, Element 4 of the ECRCHS charter petition will include the following statement under the heading of "Executive Director":

"The Executive Director serves as the educational leader of the Charter School and the chief executive of ECRA."

#### Resolution

#### NOW THEREFORE BE IT RESOLVED:

- (1) The Charter School has carefully studied and considered the potential for seamless administration and economies of scale in operating more than one conversion or start-up charter school in the West Hills area of Los Angeles. In its four-plus years of operation as a conversion comprehensive high school, ECRCHS has maintained or increased the academic and athletic stature of El Camino Real High School; has amassed a very conservative approximately 30% budgetary reserve; has acquired new property and programs to support expansion; and has always received clean annual independent financial audits.
