The Learning Continuity Plan is meant to replace the Local Control Accountability Plan (LCAP) for the 2020-21 year, and provides stakeholders with transparency and involvement in the school plan for the year. Voices Board held a public hearing on 9/17/20. This is the official approval meeting.
