**Welcome to a meeting of the Prosser School District Board of Directors!**

Your views and interest in education are important to us and to your schools. Whether your visit is for the purpose of bringing information to the board's attention, solving a problem, or simply to see what's going on, we hope you'll feel welcome and comfortable at this meeting. We also hope that you will leave with a better understanding of your school district and its board of directors.

**How the Board Operates**

As the board meeting progresses, you may notice that there is quick action on some items. This is because the board generally considers an issue for several meetings before taking action, and also because background materials on the various items are sent to members for their careful study prior to the meeting. Sometimes the board will approve a motion that encompasses many items. These items, grouped under the "consent" portion of the agenda, are considered routine. You'll be able to follow the action more carefully if you pick up a copy of the agenda that is available.

Board members are President Jason Rainer, Vice-President Elisa Riley, Director Michelle O'Brien, Director Frank Ver Mulm, and Director Brian Weinmann.

**About Board Meetings**

Regular Board meetings are held twice each month, usually on the 2nd and 4th Wednesday. The first meeting of the month is also a time for the various educational programs of the district to provide an educational presentation to the Board. These meetings begin at 6:00 p.m.

The board encourages input on all issues under discussion at the business meetings.

**About Executive Session**

The board may occasionally go into executive session, thus excluding the public and the news media from witnessing the discussion. You should know though, that the board will only discuss issues in executive session. It must, by law, take all actions in an open meeting. The law also limits what the board can legally discuss in executive session. These closed discussions may only concern litigation, personnel selection or evaluation, negotiations, complaints against an officer

or staff member, or real estate transactions where public disclosure would be damaging to individuals or the general welfare of the district. Before going into executive session, the board president must estimate the time the board will return to open session.

**Addressing the Board**

You may present a concern to the board during the time reserved for hearing public comment. If this is the case, we ask that you:

- Prior to the start of the meeting, sign in, noting the topic you intend to address to the board.
- Come to the microphone and state your name.
- Do not reflect adversely on the political or economic view, ethnic background, character, or motives of any individual.
- Do keep your comments concise, non-emotional, and brief.

The board is interested in hearing your concerns and your compliments too. It's best to call the superintendent's office a couple of days before the meeting. If this isn't possible, you can ask the board president to recognize you during the hearing section.

**Board Hearings**

The school board can be compared to a "court of last resort." If a concern cannot be solved by first talking with the teacher, principal, or appropriate district personnel, it may be forwarded to the board for hearing. Sometimes this hearing may be conducted in "executive session," meaning the public and the media are not in attendance.

**About Your Board**

Public schools are especially close to the communities they serve because they are governed by men and women selected from the community. These men and women - your school board; are volunteers who spend a great deal of time on the many details involved in providing quality education.

Board members serve four-year terms. They are required to file financial disclosure statements with the Washington State Public Disclosure Commission and must be registered voters of the school district

School board members attend meetings, keep communications open with other members of the community and represent the needs of the district before local, state, and national representatives. They make critical decisions that have a direct impact on what children learn and how they learn it. However, a school board is a legal body and can only make decisions as a body.

You may notice that many of the decisions the board must make are not directly related to instruction. School board members are also responsible for keeping the buildings and grounds in good shape, balancing the budget, protecting the district's legal interests, and providing for long-range planning.

She also talked about the KRV concert she attended with the kindergarten and TK students lots of excitement, a few tears, and plenty of hugs from teachers, but overall, the kids had a great time. With holiday assemblies and sing-alongs happening over the next few days, it's a fun but busy time for everyone. She wrapped up with an update on Red Rover, sharing that HR features should be ready by mid-February, and time and attendance will roll out in phases starting March 1, aiming for everyone to be fully on board by next school year.

She also wished everyone a happy and restful winter break with their families.

Director Brian Weinmann thanked Jim Hopwood for participating in the meeting and echoed appreciation for the treats from Kim and Michelle. He wished students, staff, and administrators a restful and safe holiday break, encouraging everyone to enjoy time with friends and family.

Explicó que, aunque algunas familias sean mudado, es típico en esta época del año, también hubo nuevos estudiantes matriculados, y la mayoría de los traslados de estudiantes han sido verificados en lugar de no contabilizados. Destacó el seguimiento continuo con un pequeño número de transferencias no confirmadas, subrayando la importancia de hacer un seguimiento preciso de esos estudiantes, y en general compartió que la matrícula se mantiene estable con un seguimiento continuo.

**IX. Informes:****A. Director de Subvenciones, Evaluación y Programas de Primaria Kevin Gilman**

El director de Subvenciones, Evaluación y Programas de Primaria, Kevin Gilman, compartió una actualización sobre varias iniciativas del distrito, incluyendo la reanudación de las reuniones de MTSS con claras diferencias innegociables en asistencia, académicos, comportamiento y aprendizaje socioemocional, que serán monitorizadas mensualmente. Destacó el trabajo continuo con los entrenadores del distrito en evaluaciones formativas comunes para mejorar el seguimiento del aprendizaje de los estudiantes, el enfoque continuo en fortalecer la enseñanza de las matemáticas mediante prácticas educativas efectivas y los esfuerzos para abordar las matemáticas como un área clave de necesidad. También compartió actualizaciones sobre la financiación de subvenciones bilingües para apoyar la enseñanza bilingüe y señaló que la primera reunión general de PAC está programada para el viernes por la noche con actividades y ponentes invitados.

**B. Asistente Superintendente Deanna Flores**

La Asistente Superintendente Deanna Flores compartió que ha estado ocupada facilitando los procesos de RH y asegurándose de que toda la información sobre el personal sea precisa, además de dar un reconocimiento a Kevin Gilman por encargarse de gran parte del trabajo de instrucción. También habló del concierto de KRV al que asistió con los alumnos de Kinder y TK, mucha emoción, algunas lágrimas y muchos abrazos por los profesores, pero en general, los niños se lo pasaron genial. Con las asambleas navideñas y los cantos durante los próximos días, es un momento divertido pero ajetreado para todos. Concluyó con una actualización sobre Red Rover, compartiendo que las funciones de RH deberían estar listas a mediados de febrero, y que el tiempo y la asistencia se desplegarán por fases a partir del 1 de marzo, con el objetivo de que todos estén completamente comprometidos para el próximo curso escolar.

**C. Superintendente Kim Casey**

La superintendente Kim Casey dio una actualización sobre varios asuntos del distrito, comenzando con el trabajo presupuestario para 2025–26. Señaló que se necesitan algunos ajustes para garantizar la precisión de los datos y, aunque eso no significa necesariamente que las cosas vayan a mejorar o empeorar, el distrito lo abordará en enero, incluyendo declarar una emergencia financiera y comenzar los procesos necesarios. Mencionó que había cerrado algunos problemas de empleados y abordado una preocupación reciente de acoso. La superintendente Casey también recorrió los edificios con el director de mantenimiento Andy Howe para revisar los planes de mantenimiento y compartió una sorprendente auditoría de jubilación en la que trabajó y que data de hace 24 años, poniendo de manifiesto la complejidad de los sistemas estatales de jubilación. Elogió la energía y creatividad que hay en todas las escuelas, recordó a la Junta las tasas de licencia de derechos de autor por proyectar películas o videos, y señaló que planea tomarse unas vacaciones y estar fuera del estado durante las vacaciones de invierno.
