Upcoming Project – Classroom Lab Renovation Howell Campus

• KIPP Memphis Public Schools received approval for the Innovative School Model grant on April 21, 2023. Inclusive in the grant are funds to renovate three classrooms at the Howell campus into the KMPS Innovative STEM Center of Excellence.

C. Emergency HVAC Repair (Howell Campus) | Gipson Mechanical Contractors

E. Food Service Management Company Services (FSMC) | Compass Group USA, Inc.

Davis made a motion to recommend the KIPP Memphis Public Schools Board of Directors approve the contract to Compass Group USA, Inc., by and through its Chartwells Division as the food service management company to provide meal services to all KIPP Memphis Public Schools' (KMPS) students effective July 1, 2023.
