I. Opening Items

A. Call the Meeting to Order

R. Crutcher called a meeting of the Operations/Facilities Committee of KIPP Memphis Public Schools to order on Wednesday Feb 14, 2024 at 4:04 PM.

II. Operations/Facilities Updates

A. Howell Windows Contract Amendment

Chief Phillips shared that the Howell campus windows contract amendment to accept a change order to include 16 additional window replacements and increase the budget not to exceed \$500,000 with Wagner General Contractors was approved by the Finance Committee on February 7, 2024.

B. 2023-24 Enrollment Trend

Chief Phillips shared the enrollment trend for the region and by school as of the end of period 5 (which ended January 24, 2024).

C. 2023-24 Attendance & Absenteeism

Chief Phillips reviewed and gave an update on the following:

- Current Attendance & Chronic Absenteeism for KMCE, KMCM, KMCH and percentage for all schools.
- Chronic absence is calculated as 10% of total days a student is enrolled.

Question:

Board Chair Davis: Do we have a comparison on how KMPS did with attendance and absenteeism last year (2023).

Chief Phillips: In the November 15, 2023 meeting, data was shared for November 2022 versus year-to-date November 2023. We will share the comparison moving forward at each of the Operations Committee meetings.

D. 2024-25 Enrollment/Recruitment Update

Chief Phillips reviewed and gave an update on the following for all schools effective the week of February 12th.

- 2024-25 Total Enrollment Targets & Enrollment, Current Re-Enrollment and % to goal.
- KMPS target for re-enrollment is to have all existing students enrolled by March 18, 2024.

Question:

Board Chair Davis: Would like to know the strategy on how KMPS is going to get the extra students and how you're tracking your current efforts to know what yields an enrollment for a new student.

Chief Phillips: We are doing multiple enrollment and recruitment actions and can share more information in the next committee meeting.

E. Facilities Projects Update

Chief Phillips gave an update as follows:

- Henry Campus - HVAC Improvement Project is about 10% complete: Target Completion Date - 3/29/24
- Howell Campus - HVAC Improvement Project is 95% complete: Target Completion Date - 2/19/24

III. Operations/Facilities Chairperson Comments

A. Committee Member Crutcher facilitated the meeting for Committee Chair Member Anderson.

- Ms. Crutcher thanked KIPP Memphis staff for welcoming her to the SST Office.
- She reminded everyone of the Kicks with KIPP event on March 7, 2024. There will be Board representation and KIPP is shooting for 100% participation.
