




This chart shows the total general purpose revenue Community School for Creative Education expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Community School for Creative Education is \$5,177,396, of which \$2,985,339 is Local Control Funding Formula (LCFF), \$1,347,005 is other state funds, \$267,655 is local funds, and \$577,397 is federal funds. Of the \$2,985,339 in LCFF Funds, \$720,546 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



## **Plan Summary [2023-24]**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Community School for Creative Education (CSCE) TK-8, now entering its thirteenth year, is among the most diverse schools in one of the most diverse neighborhood- San Antonio, and among one of the most diverse cities nationally- Oakland, California. CSCE serves its community through its first-of-a-kind intercultural Waldorf, standards-aligned, equity-focused full-service community model. It serves students by 'braiding' Waldorf strategies and methods with other best practices within a Waldorf equity-focused framework. CSCE realizes its goal in partnership with key allies. Allies span from local groups, including Faith in Action East Bay (Formerly Oakland Community Organizations/OCO), Israelite Baptist Church, Families in Action and Attitudinal Healing Connection Oakland to countywide, such as the Alameda County Food Bank, to statewide such as California Charter Schools Association (CCSA). National and international allies include the Friends of Waldorf Education, Waldorf Emergency Pedagogy, the Waldorf research and training Alanus University in Bonn, Germany, and parents' organizations such as the Waldorf School Zenzeleni in Cape Town South Africa, and the Cheng Du Waldorf School in Cheng Du China.

We are the country's first Transitional K-8 Grade Intercultural Public Waldorf School. It is proud to be an equity-focused Full Service Community School.

#### Our Vision Is:

The Community School for Creative Education envisions a future in which: all children have access to quality education; all children experience success in community and career; and youth voices contribute in valued and meaningful ways to the success of a thriving, equitable, and multi-cultural society.

#### Our Mission Is:

To achieve our vision, the Community School for Creative Education is a TK through 8th grade charter school that partners with families and communities to serve the richly diverse students of Oakland, California. The school is committed to promoting equity in education by providing a rigorous, standards-based academic program integrated into a culturally rich, arts-infused curriculum and guided by ongoing assessment. Through nurturing the whole child – head, heart, and hands – our school prepares culturally competent, well-rounded, lifelong learners and leaders to be college-ready, confident and culturally competent, and prepared to lead, contribute to, and successfully participate in our rapidly changing multicultural society.

CSCE Mission and "What Do We Stand For":

Our Mission is inspired by the Rudolf Steiner Waldorf methodology to partner with families and communities to provide a rigorous, highly personalized, college preparatory program integrated into a culturally rich, arts-infused curriculum for the diverse students of Oakland.

The School Rests on Three Pillars:

"We take care of SELF"

"We take care of OTHERS"

"We take care of our SPACE"

We commit to:

- Provide a Common-Core -aligned curriculum
- Be inspired by Waldorf principles
- Stay focused on equity & create change in our society's structure by helping all children to succeed in school and in life.

These pillars provide the school's foundation and direction.

We commit to knitting these together as a professional learning community continuously refining and reflecting on data as we go. We "Recognize Learning to Read" as a key portal on the path: We recognize: Learning to read well is the cornerstone of creating equitable outcomes for our children.

We do it through integration of:

• Direct and systematic phonics instruction, close reading, guided reading, shared reading and interactive reading in Reader's and Writer's workshop

• Core Waldorf practices: Teaching through the artistic; employing main lesson; main lesson book; reinforcement through subjects. We follow cutting-edge learning theory by drawing from Waldorf practices in our lesson design which moves from whole (the story) to part (direct instruction) and back to whole (the artistic activity).

We Aim to Be Preventive Rather Than Reactive.

The aim of CSCE is to focus on prevention, intervention, and acceleration of all students in a developmentally rich way.

To achieve this goal, we are committed to create a process similar to Multiple Response to Intervention (M-RTI) and Positive Behavior Interventions and Supports (PBIS) that together provide staff a routine systematic way to identify students in need early on so they can be provided with appropriate interventions.

#### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

One major success for Community School for Creative Education is in reduction in the Suspension Rate and English Learner indicators.

The success of having a 0.9% suspension rate can be attributed to the use of restorative practices and alternatives to suspension. We understand that behavior is a form

of communication and action of unmet needs. Supporting students in identifying the root cause and coming up with alternative positive actions has generated an improvement in self-reflection and behavior management.

Social Emotional Wellness: Morning social-emotional learning lessons/experiences in support of mental health and readiness for the learning school day; when needed our Dean of Student, mental health counselor, Academic Programs and Community Partners Coordinator and school admin push into classrooms to address learning social and emotional learning needs. Having staff model for students the appropriate ways of navigating conflict or emotional moments has proven to be a valuable tool for teachers in empowering students to help students build social emotional skills for nurturing positive relationships, managing emotions, and setting personal goals that can be utilized at school and in life.

In 21-22, we raised our reclassification rate from 50% to 66.7%. Consistent data monitoring for English Learner Progress has been a key component in increasing achievement for English Learners. We created the Multilingual Learner Intervention Specialist position to increase monitoring, designated time and ongoing supports and interventions throughout the school year.

#### **Reflections: Identified Need**

Community School for Creative Education's 2022 California School Dashboard shows no

"Not Met" for all local indicators due to not having uploaded the annual reflection responses to the Dashboard before the September deadline. Internal steps were established to ensure that annual reflections for local indicators are uploaded to the dashboard prior to the September deadline.

Community School for Creative Education met the criteria to be eligible for ATSI (Additional Targeted Support & Improvement) in the 2022-23 school year. Schools are eligible for ATSI in 2022-23 if one or more subgroups meets the following criteria: All indicators at the lowest status level but one indicator at another status level on the 2022 California School Dashboard. On Community School for Creative Education's 2022 California School

Dashboard, 62.1% of students were chronically absent, English Language Arts achievement is Low and Mathematics achievement is very low. Community School for Creative Education plans to continue efforts to increase attendance, including informing parents and students about the importance of regular school attendance for student academic achievement and growth. Funds have been allocated for the creation of the Extended Learning Opportunities Program Coordinator to serve as the primary point person for the daily monitoring, family outreach and coordination of services.

CSCE's internal analysis identified areas of growth in supporting EL and SPED subgroups, lowering the Chronic Absenteeism rate, and supporting teachers in implementing all standards, including NGSS. CSCE plans to continue to support multilingual learners through the Multilingual Learning Intervention Specialist position and the development of an Intervention designated course taught by a credentialed educator.

Academic Achievement: ELA and Math

Community School for Creative Education students demonstrated a significant decline in both school-wide and within student groups in their ELA and Math mastery on the CAASPP. However, our focus remains on the needs of English Learners, Black/African American Students and Students with Disabilities, student groups which are making similar growth to other groups but demonstrate lower percentages of proficiency. To address these student groups' needs, we have put the following in place:

Assessments and Data Driven Instruction – We continue to administer the NWEA Diagnostic Assessments as a measure of academic progress and growth to students in 3-8th. Data from this assessment and others help us identify and provide targeted interventions to students struggling, set goals, and monitor progress. To refine these systems next year, we will focus heavily on the process of Teacher and Student Data

Chats, ensuring that every student at the school has met with their teacher to review their progress and set goals, and every teacher has met with administrators to do the same.

After School Tutoring Program – A pilot program for selected students to receive additional one-on-one instruction in a quiet and safe environment.

COST and Intervention - We have strengthened our COST (Coordination of Student Team) and Intervention systems as systematic approaches to support our students' learning loss. Monitoring data and individual academic achievement has been key to providing our students the intervention necessary, particularly for our Student Groups. Through our Coordination of Services Team (CoST) we are able to collectively study each student

who needs immediate academic or behavioral support.

Summer Learning Lab – We implemented a Summer Learning Lab to ensure students received increased academic and social support, and to counteract the "summer slide." CSCE staff provided the programming and differentiation to extend learning opportunities for students in key academic areas as well as enrichment. Programming included targeted summer learning specifically for the highest needs students based on data, as well as new students entering CSCE.

We were able to increase student achievements with several sub-groups, increased school/community connectedness, and maintained a highly qualified teacher in every classroom, thus advancing to fulfill our three LCAP goals across a range of metrics as detailed.

Our Accountability is To Ourselves: We commit to conducting ongoing inquiry together around focus areas, collecting data and Reflecting on outcomes (Cycle of Inquiry). By inquiring and assessing frequently, regularly and using multiple measures, we learn how to do our work better. We engage multiple modalities and interdisciplinary curriculum drawing from Waldorf.

Our goal is to: Meet Common-Core Standards: 80% of 5th graders and beyond will meet or exceed standards in both English Language Arts and Math.

Specifically, in reading, our target is:

- By end of first grade, a fluency rate of 60 words per minute
- By end of third grade, a fluency rate of 110 words per minute
- By end of fifth grade, a fluency rate of 140 words per minutes

Do that and more: Develop life-long leaders by harnessing Waldorf inspired methods

Do that for all: Both those who are "school dependent" (dependent learners) and those who are not (independent learners)

# **Engaging Educational Partners**

CSCE is commitment to meaningfully engage in the planning process educational partners including staff, students, families and the community. CSCE invites educational partner engagement throughout the school year through a variety of means, including meetings, surveys, and informal conversations. CSCE values input from a variety of partners, including teachers, administrators, school staff, parents and

students, in decisions that impact the educational program and student services.

Met engagement actions and information include:

- 1. Monthly Community Chats with the Head of School
- 2. Meetings with CSCE English Learner Advisory Committee [ELAC]

Purpose: To review student achievement data as part of an annual comprehensive needs assessment during their fall meetings to determine the school's areas of strength and greatest areas of growth. These committees are led by the Head of School and the Multilingual Learner Intervention Specialist and include school teachers, staff and parents, including parents of English Learners. The committees serve as the school's parent advisory and English Learner parent advisory councils. All parents, including parents of students with special needs, are encouraged to attend committee meetings. Committee meetings are open to the entire school community, with notices provided to all parents and agendas posted publicly in advance of the meetings. Translation is provided at meetings as needed.

3. Head of School, Assistant Head of School and Academic Programs and Community Partners Coordinator Meetings

Purpose: To regularly review data related to student achievement, student outcome, and school climate, reflecting on areas of greatest need to inform the school's goals. School data is also shared with all teachers to provide additional input through staff professional development and coaching meetings.

#### A summary of the feedback provided by specific educational partners.

Feedback from families and staff helped us secure budget priorities around sustained support to our students with special needs and building maintenance. The feedback from staff helped us identify the key need to learn to leverage LCAP more strategically as formative reflection and accountability tool going forward. It guides us to facilitate CORE Panorama Surveys for students, staff and families again two times a year going into 2023-24.

Feedback from teachers and school leaders identified the English Learner student group as a priority. Teachers expressed needing ongoing Professional Learning throughout the year in discussions focused on the importance of building academic vocabulary. Additional feedback from both teachers and school leaders focused on how to address learning gaps, and what needs to be done now to prepare students for the next grade level, including intervention and reteaching. Teacher and school leader input also supported the need for additional Instructional Assistants to provide individual and small group support within the classrooms as well as a Reading Intervention Teacher to provide targeted support in a small group setting outside of the classroom.

Parent feedback indicated strong support for the school's communication and supports during the school year. There was positive parents feedback regarding school curricular programs. Parent input did express a desire to continue to focus on educating the whole child, incorporating art and social emotional education and programs.

Student input indicated strong academic motivation and high expectations of adults in school. However, fewer students expressed a feeling of school connectedness and meaningful participation.

We chose to sustain and deepen the LCAP priorities from 2021 as the stakeholder feedback directed us to continue and intensify rather than redirect.

Local educational partners possess valuable perspectives and insights about an LEA's programs and services. Effective strategic planning will incorporate these perspectives and insights in order to identify potential goals and actions to be included in the LCAP.

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
