A. MCPSA Board Diagnostic Survey Results

Strengths:

- 1. 9 out of 11 responses (11% is one person)
- 2. Consensus on most responses
 - 1. Consistent willingness to discuss the impact of systemic racism within the school full consensus (agree or strongly agree)
 - 2. Governance compliant with bylaws and effectiveness of meetings

Opportunities:

- 1. Recruit new trustees with targeted professional expertise (HR, Legal & Fundraising)
- 2. Regular review of student achievement data consistent access to a data dashboard
- 3. ED goals and progress monitoring
- 4. Annual board self-assessment

Discussion/Inquiry:

- In the last 12 months, the Board and the school leader have had at least one substantive conversation clarifying the balance between governance and management and who makes what decisions.
